A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING FUNDS TO MIRA MESA TOWN COUNCIL, NOLAH, INC., AND VIETNAMESE AMERICAN YOUTH ALLIANCE, PURSUANT TO COUNCIL POLICY 100-06, "CITY COUNCIL FUNDING OF COMMUNITY PROJECTS, PROGRAMS, AND SERVICES."

WHEREAS, the Council of the City of San Diego (City Council) adopted Council Policy 100-06, titled "City Council Funding of Community Projects, Programs and Services" on June 28, 2011, by San Diego Resolution R-306903 (July 7, 2011); and

WHEREAS, among other things, Council Policy 100-06 establishes guidelines and uniform eligibility requirements for funding Community Projects, Programs, and Services with non-profit community organizations and public agencies for community, social, environmental, cultural, or recreational needs which serve a lawful public purpose; and

WHEREAS, the City of San Diego (City) received and evaluated three applications for Community Projects, Programs, and Services funding for the following purposes:

ORGANIZATION	PROGRAM/ACTIVITY	PUBLIC BENEFIT
Mira Mesa Town Council	Street Fair and Business Promotion	Bring together community members and local businesses
NOLAH, Inc.	11th Annual Veterans Appreciation Dinner	Honor and support active military members
Vietnamese American Youth Alliance	San Diego Tet-Festival	Build community engagement and provide cultural education opportunities

WHEREAS, it is the determination of the City Council that the above-described programs fits within the parameters of Council Policy 100-06; and

WHEREAS, Council District 6 recommends an allocation of \$7,500 to the Mira Mesa Town Council for the Street Fair and Business Promotion, as set forth in this resolution; and

WHEREAS, Council District 6 recommends an allocation of \$2,000 to NOLAH, Inc. for the 11th Annual Veterans Appreciation Dinner, as set forth in this resolution; and

WHEREAS, Council District 6 recommends an allocation of \$15,000 to the Vietnamese American Youth Alliance for the San Diego Tet-Festival, as set forth in this resolution; and

WHEREAS, the Office of the City Attorney has drafted this resolution based on the information provided by City staff, including information provided by affected third parties and verified by City staff, with the understanding that this information is complete, true, and accurate; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocations described in this resolution are made for a public purpose.

BE IT FURTHER RESOLVED, that the Mayor, or their designee, is authorized and directed to execute, for and on behalf of the City, Community Projects, Programs, and Services FY 2023 City Council Allocations Agreements between the City of San Diego and (1) the Mira Mesa Town Council in an amount not to exceed \$7,500, (2) NOLAH, Inc. in an amount not to exceed \$2,000, and (3) the Vietnamese American Youth Alliance in an amount not to exceed \$15,000, under the terms and conditions set forth in the Agreements on file in the Office of the City Clerk as Document No. RR- 314654-1 for the Mira Mesa Town Council, Document No. RR- 314654-2 for NOLAH, Inc., and Document No. RR- 314654-3 for the Vietnamese American Youth Alliance.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$24,500 from Council District 6: Community Projects, Programs, and Services budget Fund No. 100000, G/L Account No. 512059, Cost Center 1106110006, all to

provide funds for the above-referenced Agreements, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.


