A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING FUNDS TO CASA FAMILIAR, HERENCIA HISPANA SAN DIEGO, SAN DIEGO SYMPHONY ORCHESTRA ASSOCIATION, AND TEATRO SAN DIEGO, PURSUANT TO COUNCIL POLICY 100-06, "CITY COUNCIL FUNDING OF COMMUNITY PROJECTS, PROGRAMS, AND SERVICES."

WHEREAS, the Council of the City of San Diego (City Council) adopted Council Policy 100-06, titled "City Council Funding of Community Projects, Programs and Services" on June 28, 2011, by San Diego Resolution R-306903 (July 7, 2011); and

WHEREAS, among other things, Council Policy 100-06 establishes guidelines and uniform eligibility requirements for funding Community Projects, Programs, and Services with non-profit community organizations and public agencies for community, social, environmental, cultural, or recreational needs which serve a lawful public purpose; and

WHEREAS, the City of San Diego (City) received and evaluated four applications for Community Projects, Programs, and Services funding for the following purposes:

Casa Familiar	Dia de Muertos & Pumpkin Patch Festival	Providing cultural activities and fun experiences for the community.
Herencia Hispana San Diego	National Hispanic Heritage Month	Sharing the contributions and achievements made by Hispanic Americans.
San Diego Symphony Orchestra Association	Music Connects District 8	Providing live music to the community.
Teatro San Diego	West Side Story in San Ysidro	Providing musical theatre exposure to South Bay residents.

WHEREAS, it is the determination of the City Council that the above-described program fits within the parameters of Council Policy 100-06; and

WHEREAS, Council District 8 recommends an allocation of \$15,000 to Casa Familiar for the Dia de Muertos and Pumpkin Patch Festival, as set forth in this resolution; and

WHEREAS, Council District 8 recommends an allocation of \$2,000 to Herencia Hispana San Diego for National Hispanic Heritage Month, as set forth in this resolution; and

WHEREAS, Council District 8 recommends an allocation of \$10,000 to San Diego Symphony Orchestra Association for Music Connects District 8, as set forth in this resolution; and

WHEREAS, Council District 8 recommends an allocation of \$5,000 to Teatro San Diego for West Side Story in San Ysidro, as set forth in this resolution; and

WHEREAS, the Office of the City Attorney has drafted this resolution based on the information provided by City staff, including information provided by affected third parties and verified by City staff, with the understanding that this information is complete, true, and accurate; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocations described in this resolution are made for a public purpose.

BE IT FURTHER RESOLVED, that the Mayor, or their designee, is authorized and directed to execute, for and on behalf of the City, a Community Projects, Programs, and Services FY 2023 City Council Allocations Agreement between the City of San Diego and (1) Casa Familiar in an amount not to exceed \$15,000, (2) Herencia Hispana in an amount not to exceed \$2,000, (3) San Diego Symphony Orchestra Association in an amount not to exceed \$10,000, and (4) Teatro San Diego in an amount not to exceed \$5,000, under the terms and conditions set forth in the Agreements on file in the Office of the City Clerk as Document No.

RR-\_\_\_\_314681.1 for Casa Familiar, Document No. RR-\_\_314681.2 for Herencia Hispana San Diego, Document No. RR\_\_314681.3 for San Diego

Symphony Orchestra Association, and Document No. RR-\_314681.4 for Teatro

San Diego.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$32,000 from Council District 8: Community Projects, Programs, and Services budget Fund No. 100000, G/L Account No. 512059, Cost Center 1108110008, all to provide funds for the above-referenced Agreements, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
