

RESOLUTION NUMBER R- 314686DATE OF FINAL PASSAGE MAR 28 2023

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING FUNDS TO ACCESS YOUTH ACADEMY, FOURTH DISTRICT SENIOR RESOURCES CENTER, SAN DIEGO YOUNG ARTISTS MUSIC ACADEMY, INC., REVIVAL TIME COMMUNITY CHURCH OF GOD IN CHRIST, PURSUANT TO COUNCIL POLICY 100-06, "CITY COUNCIL FUNDING OF COMMUNITY PROJECTS, PROGRAMS, AND SERVICES."

WHEREAS, the Council of the City of San Diego (City Council) adopted Council Policy 100-06, titled "City Council Funding of Community Projects, Programs and Services" on June 28, 2011, by San Diego Resolution R-306903 (July 7, 2011); and

WHEREAS, among other things, Council Policy 100-06 establishes guidelines and uniform eligibility requirements for funding Community Projects, Programs, and Services with non-profit community organizations and public agencies for community, social, environmental, cultural, or recreational needs which serve a lawful public purpose; and

WHEREAS, the City of San Diego (City) received and evaluated four applications for Community Projects, Programs, and Services funding for the following purposes:

ORGANIZATION	PROGRAM/ACTIVITY	PUBLIC BENEFIT
Access Youth Academy	Community Access Center	Bridges the digital divide for students.
Fourth District Senior Resources Center	Public Service	Helps San Diego seniors socialize and live more independently.
San Diego Young Artists Music Academy, Inc.	Recording Studio	Provides an after-school music program for low-income children.
Revival Time Community Church of God in Christ	Youth Homeless Placement Program	Reduces youth homelessness in San Diego.

WHEREAS, it is the determination of the City Council that the above-described program fits within the parameters of Council Policy 100-06; and

WHEREAS, Council District 4 recommends an allocation of \$5,000 to Access Youth Academy for the Community Access Center, as set forth in this resolution; and

WHEREAS, Council District 4 recommends an allocation of \$20,000 to the Fourth District Senior Resources Center for Public Service, as set forth in this resolution; and

WHEREAS, Council District 4 recommends an allocation of \$5,000 to San Diego Young Artists Music Academy, Inc. for the Recording Studio, as set forth in this resolution; and

WHEREAS, Council District 4 recommends an allocation of \$5,000 to Revival Time Community Church of God in Christ for the Youth Homeless Placement Program, as set forth in this resolution; and

WHEREAS, the Office of the City Attorney has drafted this resolution based on the information provided by City staff, including information provided by affected third parties and verified by City staff, with the understanding that this information is complete, true, and accurate; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocations described in this resolution are made for a public purpose.


BE IT FURTHER RESOLVED, that the City Council waives Council Policy 100-06, section 8, which provides: "Community Projects, Programs, and Services funding should be considered a one-time resource, and planned uses should be one-time in nature, to avoid service interruptions or employee impacts if funding is discontinued."

BE IT FURTHER RESOLVED, that the Mayor, or their designee, is authorized and directed to execute, for and on behalf of the City, a Community Projects, Programs, and Services FY 2023 City Council Allocations Agreement between the City of San Diego and (1) Access

Youth Academy in an amount not to exceed \$5,000, (2) Fourth District Senior Resources Center in an amount not to exceed \$20,000, (3) San Diego Young Artists Music Academy, Inc. in an amount not to exceed \$5,000, and (4) Revival Time Community Church of God in Christ in an amount not to exceed \$5,000, under the terms and conditions set forth in the Agreements on file in the Office of the City Clerk as Document No. RR- 314686.1 for Access Youth Academy, Document No. RR- 314686.2 for Fourth District Senior Resources Center, Document No. RR- 314686.3 for San Diego Young Artists Music Academy, Inc., and Document No. RR- 314686.4 for Revival Time Community Church of God in Christ.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$35,000 from Council District 4: Community Projects, Programs, and Services budget Fund No. 100000, G/L Account No. 512059, Cost Center 1104110004, all to provide funds for the above-referenced Agreements, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.


