A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO CONFIRMING AN APPOINTMENT TO THE
CIVIL SERVICE COMMISSION.

WHEREAS, the City of San Diego's Civil Service Commission (Commission) is
established in San Diego Charter (Charter) section 41(b); and

WHEREAS, the Commission has supervision over the selection, promotion, and removal
of all City of San Diego (City) employees, subject to the Civil Service provisions in Charter
section 115; and

WHEREAS, the Commission is to be composed of five members who are electors of the
City; and

WHEREAS, members are to serve five-year terms and serve until a successor is
appointed and qualified, and are to be appointed so that no more than one individual's term shall
expire in a given year; and

WHEREAS, the Mayor shall appoint Commission members, subject to confirmation by
the Council of the City of San Diego; and

WHEREAS, members shall not hold any other office in City government; and

WHEREAS, the Office of the City Attorney has drafted this resolution based on the
information provided by City staff, including information provided by affected third parties and
verified by City staff, with the understanding that this information is complete, true, and
accurate; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the following appointment by the Mayor of the City of San Diego, to serve as a member of the City of San Diego's Civil Service Commission, for a term ending as indicated, is made and hereby confirmed:




