A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO CONFIRMING THE APPOINTMENT OF
COUNCILMEMBER JENNIFER CAMPBELL TO CITY
COUNCIL'S ECONOMIC DEVELOPMENT AND
INTERGOVERNMENTAL RELATIONS STANDING
COMMITTEE FOR CALENDAR YEAR 2023.

WHEREAS, Rule 6.1 of the Rules of the Council, San Diego Municipal Code section
22.0101, provides for specific standing committees of the Council of the City of San Diego
(Council); and

WHEREAS, Rule 6.2.1 provides that no later than the second Council meeting in January
of each year, the Council President shall nominate the committee chair, vice chair, and
committee members for each committee, subject to confirmation by a majority vote of the
Council; and

WHEREAS, Council adopted San Diego Ordinance O-21576 (Oct. 6, 2022) amending
the Rules of Council to, among other things, require the Council President's nomination indicate
the number of committee members assigned to each standing committee, except the Committee
on Rules; and

WHEREAS, Council President Sean Elo-Rivera submitted nominations for the committee
chairs, vice chairs, and committee members for the standing committees of the Council for
calendar year 2023, and Council confirmed the appointments by San Diego Resolution R-314555
(Dec. 15, 2022), including the Economic Development and Intergovernmental Relations
Committee with three members; and

WHEREAS, Council President Sean Elo-Rivera recently submitted a nomination for Councilmember Jennifer Campbell as a fourth committee member for the Economic Development and Intergovernmental Relations Committee; and

WHEREAS, the Office of the City Attorney has drafted this resolution based on the information provided by City staff, with the understanding that this information is complete, true, and accurate; and

WHEREAS, under San Diego Charter section 280(a)(1), this resolution is not subject to veto by the Mayor because this matter is exclusively within the purview of the Council and not affecting the administrative service of the City under the control of the Mayor; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, the Council hereby suspends Rule 6.2.1 of the Rules of the Council, San Diego Municipal Code section 22.0101 to consider the Council President's nomination of Councilmember Campbell to the Economic Development and Intergovernmental Relations Committee after the second week of January.


BE IT FURTHER RESOLVED, that the Council confirms the Economic Development and Intergovernmental Relations Committee shall have four committee members.

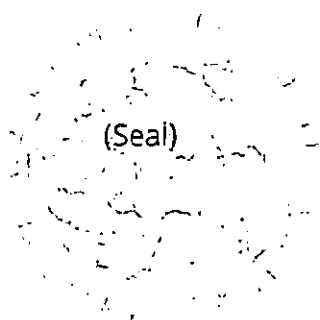
