A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO ESTABLISHING NEW COUNCIL POLICY 900-22
TITLED "PRIORITIZING ACTIONS FOR CLIMATE ACTION
PLAN IMPLEMENTATION."

WHEREAS, in 2015, the City of San Diego (City) adopted the Climate Action Plan, committing to reduce the City's annual greenhouse gas (GHG) emissions 50 percent by 2035; and

WHEREAS, in 2022, the City updated the Climate Action Plan to establish new goals, targets, and actions, including a goal of net zero GHG emissions by 2035 (CAP); and

WHEREAS, the CAP sets forth a comprehensive set of strategies, measures, targets, and actions to achieve the City's interim 2030 fair share reduction goal and 2035 goal of net zero GHG emissions; and

WHEREAS, the CAP includes six strategies, each of which has numeric targets showing how the strategy helps the City achieve its overall GHG reduction goals; and

WHEREAS, the Sustainability and Mobility Department developed a detailed Climate Action Implementation Plan (CAIP) that describes how the City will implement each CAP measure, including responsible departments, partnerships, estimated costs, and the near-term work necessary for the realization of the associated targets over a five-year span; and

WHEREAS, within the CAIP, as well as the CAP, each of the actions identified to achieve CAP measures and targets have corresponding prioritization metrics that may be utilized to prioritize the actions within the CAP; and

WHEREAS, while the CAP and CAIP contain numerous metrics that can be utilized to prioritize the various actions, neither the CAP nor CAIP provide how these metrics are to be weighed against one another; and

WHEREAS, the Independent Budget Analyst was instructed to draft a Council policy to assist in evaluating and prioritizing actions in the CAP; and

WHEREAS, the new Council Policy 900-22 sets forth a weighted table which provides two sets of weights for the four different types of action set forth in the CAIP; and

WHEREAS, the Environment Committee of the City Council heard this item at its March 9, 2023 meeting and voted unanimously to forward it to the full Council with a recommendation to establish new Council Policy 900-22, with an amendment to have Council review the policy in one year; and

WHEREAS, the Office of the City Attorney has drafted this resolution based on the information provided by City staff, including information provided by affected third parties and verified by City staff, with the understanding that this information is complete, true, and accurate; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that Council Policy 900-22, titled "Prioritizing Actions for Climate Action Plan Implementation" is established as set forth in the document on file in the Office of the City Clerk as Document No. RR- **314694**

BE IT FURTHER RESOLVED, that the City Clerk is instructed to update the Council Policy Manual to include Council Policy 900-22.
