A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE MAYOR, OR HIS DESIGNEE, TO EXECUTE CHANGE ORDER NO. 4 TO CONSTRUCTION CONTRACT K-19-1982-DBB-3 WITH CASS CONSTRUCTION, INC., FOR ADDITIONAL CONSTRUCTION OPERATIONS IN AN AMOUNT NOT TO EXCEED \$4,206,009.49 WITHIN THE OTAY 2ND PIPELINE PHASE 1 PROJECT, AND TAKING RELATED ACTIONS.

WHEREAS, in November 2019, the City awarded a construction contract K-19-1982-DBB-3 (Contract) to Cass Construction, Inc. (Contractor) for construction of the Otay 2nd Pipeline Phase 1 project (Project); and

WHEREAS, during construction 24 conflicts with existing underground utilities were discovered by Contractor while doing investigatory potholing, causing a redesign of a portion of the Project; and

WHEREAS, a construction change order (Change Order No. 4) is now needed to provide for additional trenching, additional pipeline segments and valves, additional traffic control, and associated labor necessary to accommodate the redesign; and

WHEREAS, Change Order No. 4 will increase the Contract amount by \$4,206,009.49, for a total Project cost of \$20,397,762.80, and will extend the Contract term for an additional 447 days; and

WHEREAS, the Office of the City Attorney has drafted this resolution based on the information provided by City staff, with the understanding that this information is complete, true, and accurate; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Mayor, or his designee, is authorized to execute Change Order No. 4 with Cass Construction, Inc., for

additional construction operations for an amount not to exceed \$4,206,009.49 within the Otay 2nd Pipeline Phase 1 project.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend a total amount not to exceed \$4,206,009.49 for Change Order No. 4 in CIP A-KA.00003, Large Diameter Water Transmission PPL (B-14092, Otay 2nd Pipeline Phase 1), Fund 700010, Water Utility CIP, for the purpose of executing this construction change order.
