A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO AUTHORIZING THE FIRST AMENDMENT TO
THE AGREEMENT WITH STROMMEL, INC., DBA LEHR
FOR PANASONIC TABLETS, ACCESSORIES, AND
WARRANTY SERVICES.

WHEREAS, in September 2019, the City entered into a five-year agreement with
Strommel, Inc., dba Lehr (Lehr) for the leasing of ruggedized Panasonic tablets, accessories, and
warranty services pursuant to Invitation to Bid No. 10089517-19-V (Agreement); and

WHEREAS, the Agreement included a third-party three-year leasing agreement with CIT
Bank, N.A. (CIT) for financing and leasing of the tablets; and

WHEREAS, the lease with CIT includes an option to purchase the tablets for fair market
value at the end of the lease term; and

WHEREAS, the San Diego Police Department (SDPD) needs the ruggedized tablets for
use in patrol vehicles, specialized units, and for use by parking enforcement officers; and

WHEREAS, the tablets support critical police services and can withstand vibration,
physical impact, and varying environmental factors officers encounter in the field; and

WHEREAS, SDPD now wishes to exercise the lease-end purchase option for the tablets,
providing the flexibility to modify or customize the tablets as needed; and


WHEREAS, accordingly, SDPD seeks to amend the Agreement with Lehr to increase the
not to exceed amount by \$814,000 for a total not to exceed amount of \$4,614,000 over the term
of the Agreement.

WHEREAS, the Office of the City Attorney has drafted this resolution based on the information provided by City staff, with the understanding that this information is complete, true, and accurate; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Mayor, or his designee is authorized to execute a First Amendment to the Agreement with Strommel, Inc., dba Lehr increasing the total not to exceed amount to \$4,614,000, on file in the office of the City Clerk as Document No. RR-**314704**

BE IT FUTHER RESOLVED, that the Chief Financial Officer is authorized to expend an additional \$814,000 for a total not to exceed amount of \$4,614,000 over the full term of the Agreement, from General Fund 100000, for the purpose of executing this First Amendment, contingent upon the adoption of the Annual Appropriation Ordinance for the applicable fiscal year, and contingent upon the Chief Financial Officer furnishing one or more certificates certifying that funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
