A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING FUNDS TO POINT LOMA SUMMER CONCERTS, PORTAL BRAZIL USA, AND SAN DIEGO COMMUNITY BIRTH CENTER PURSUANT TO COUNCIL POLICY 100-06, "CITY COUNCIL FUNDING OF COMMUNITY PROJECTS, PROGRAMS, AND SERVICES."

WHEREAS, the Council of the City of San Diego (City Council) adopted Council Policy 100-06, titled "City Council Funding of Community Projects, Programs and Services" on June 28, 2011, by San Diego Resolution R-306903 (July 7, 2011); and

WHEREAS, among other things, Council Policy 100-06 establishes guidelines and uniform eligibility requirements for funding Community Projects, Programs, and Services with non-profit community organizations and public agencies for community, social, environmental, cultural, or recreational needs which serve a lawful public purpose; and

WHEREAS, the City of San Diego (City) received and evaluated three applications for Community Projects, Programs, and Services funding for the following purposes:

ORGANIZATION	PROGRAM/ACTIVITY	PUBLIC BENEFIT
Point Loma Summer Concerts	Five Free Community Concerts in Point Loma	Provides five free family- friendly concerts for the community.
Portal Brazil USA	Arraia do Portal	Promotes culture and diversity.
San Diego Community Birth Center	Shades of Fatherhood	Provides accessible healthcare.

WHEREAS, it is the determination of the City Council that the above-described programs fit within the parameters of Council Policy 100-06; and

WHEREAS, Council District 2 recommends an allocation of \$5,000 to Point Loma Summer Concerts technical production costs and artist compensation, as set forth in this resolution; and

WHEREAS, Council District 2 recommends an allocation of \$2,000 to Portal Brazil USA for stage and sound equipment, event decorations, rentals, set up, musician fees, and other event costs, as set forth in this resolution; and

WHEREAS, Council District 2 recommends an allocation of \$2,000 to San Diego Community Birth Center for marketing materials, flyers, and event rental space, as set forth in this resolution; and

WHEREAS, the Office of the City Attorney has drafted this resolution based on the information provided by City staff, including information provided by affected third parties and verified by City staff, with the understanding that this information is complete, true, and accurate; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocations described in this resolution are made for a public purpose.

BE IT FURTHER RESOLVED, that, for Point Loma Summer Concerts, the City Council waives Council Policy 100-06, section 3(g), which provides: "An organization may not apply to receive funding for an event or program which has already occurred, nor any capital improvement, goods, supplies, materials, or equipment which have already been purchased."

BE IT FURTHER RESOLVED, that the Mayor, or their designee, is authorized and directed to execute, for and on behalf of the City, a Community Projects, Programs, and Services FY 2023 City Council Allocations Agreements between the City of San Diego and (1) Point Loma Summer Concerts in an amount not to exceed \$5,000, (2) Portal Brazil USA in an amount not to exceed \$2,000, and (3) San Diego Community Birth Center in an amount not to exceed

\$2,000, under the terms and conditions set forth in the Agreements on file in the Office of the City Clerk as Document No. RR- 314716-1 for Point Loma Summer Concerts, Document No. RR- 314716-2 for Portal Brazil USA, and Document No. RR- 314716-3 for San Diego Community Birth Center.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$9,000 from Council District 2: Community Projects, Programs, and Services budget Fund No. 100000, G/L Account No. 512059, Cost Center 1102110002, all to provide funds for the above-referenced Agreements, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
