A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO ALLOCATING FUNDS TO BARRIO LOGAN
COLLEGE INSTITUTE, SPACE 4 ART, AND SAN DIEGO
OPERA ASSOCIATION, PURSUANT TO COUNCIL POLICY
100-06, "CITY COUNCIL FUNDING OF COMMUNITY
PROJECTS, PROGRAMS, AND SERVICES."

WHEREAS, the Council of the City of San Diego (City Council) adopted Council Policy
100-06, titled "City Council Funding of Community Projects, Programs and Services" on
June 28, 2011, by San Diego Resolution R-306903 (July 7, 2011); and

WHEREAS, among other things, Council Policy 100-06 establishes guidelines and
uniform eligibility requirements for funding Community Projects, Programs, and Services with
non-profit community organizations and public agencies for community, social, environmental,
cultural, or recreational needs which serve a lawful public purpose; and

WHEREAS, the City of San Diego received and evaluated three applications for
Community Projects, Programs, and Services funding for the following purposes:

ORGANIZATION	PROGRAM/ACTIVITY	PUBLIC BENEFIT
Barrio Logan College Institute	Barrio Logan College Institute Annual Open House	Celebrating the academic milestones of Barrio Logan College Institute students.
Space 4 Art	Art Shows & Open Studios	Creating outlets for creativity and the expression of art for all.
San Diego Opera Association	Equal Voices	Increasing cultural awareness through Latin music;

and

WHEREAS, it is the determination of the City Council that the above-described program
fits within the parameters of Council Policy 100-06; and

WHEREAS, Council District 8 recommends an allocation of \$5,000 to Barrio Logan College Institute for the Barrio Logan College Institute Annual Open House, as set forth in this resolution; and

WHEREAS, Council District 8 recommends an allocation of \$2,000 to Space 4 Art for Art Shows and Open Studios, as set forth in this resolution; and

WHEREAS, Council District 8 recommends an allocation of \$5,000 to San Diego Opera Association for Equal Voices, as set forth in this resolution; and

WHEREAS, the Office of the City Attorney has drafted this resolution based on the information provided by City staff, including information provided by affected third parties and verified by City staff, with the understanding that this information is complete, true, and accurate; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocations described in this resolution are made for a public purpose.

BE IT FURTHER RESOLVED, that, for San Diego Opera Association, the City Council waives Council Policy 100-06, section 3(g), which provides: "An organization may not apply to receive funding for an event or program which has already occurred, nor any capital improvement, goods, supplies, materials, or equipment which have already been purchased."

BE IT FURTHER RESOLVED, that, for Barrio Logan College Institute and Space 4 Art, the City Council waives Council Policy 100-06, section 8, which provides: "Community Projects, Programs and Services funding should be considered a one-time resource, and planned uses should be one-time in nature, to avoid service interruptions or employee impacts if funding is discontinued."


BE IT FURTHER RESOLVED, that the Mayor, or their designee, is authorized and directed to execute, for and on behalf of the City, a Community Projects, Programs, and Services

FY 2023 City Council Allocations Agreement between the City of San Diego and (1) Barrio Logan College Institute in an amount not to exceed \$5,000, (2) Space 4 Art in an amount not to exceed \$2,000, and (3) San Diego Opera Association in an amount not to exceed \$5,000, under terms and conditions set forth in the Agreements on file in the Office of the City Clerk as Document No. RR- 314718-1 for Barrio Logan College Institute, Document No. RR- 314718-2 for Space 4 Art, and Document No. RR- 314718-3 for San Diego Opera Association.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$12,000 from Council District 8: Community Projects, Programs, and Services budget Fund No. 100000, G/L Account No. 512059, Cost Center 1108110008, all to provide funds for the above-referenced Agreements, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
