A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO APPROVING THE SETTLEMENT AGREEMENT
BETWEEN TERRIE VORONO AND THE CITY OF SAN
DIEGO

WHEREAS, on June 4, 2019, Terrie Vorono filed a suit against the City of San Diego alleging personal injuries arising from a May 21, 2018, trip and fall on the sidewalk at 5203 Cassandra Lane, in San Diego, California, entitled *Terrie Vorono v. City of San Diego*, San Diego Superior Court Case No. 37-2019-00028309-CU-PO-CTL; and

WHEREAS, in Closed Session on March 6, 2023, the San Diego City Council, by the following votes: Yeas, Districts 1, 2, 4, 5, and 6; Nay, None; and Absent, Districts 3, 7, 8, and 9; approved the Settlement for an amount consistent with the amounts set forth below;

BE IT RESOLVED, by the Council of the City of San Diego, that the Council:

1. Authorizes the Mayor or his designee to pay the sum of \$300,000 from the Public Liability Fund No. 720045, in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorney fees, against City of San Diego, its agents and employees, arising from the personal injury complaint filed by Plaintiff Terrie Vorono.

2. Authorizes the Chief Financial Officer to expend an amount not to exceed \$300,000 from the Public Liability Fund No. 720045, for the purpose of settling this claim.


