A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING FUNDS TO ASSISTANCE LEAGUE OF GREATER SAN DIEGO; CALIFORNIA WESTERN SCHOOL OF LAW; CATHOLIC CHARITIES, DIOCESE OF SAN DIEGO; AND EPISCOPAL COMMUNITY SERVICES, PURSUANT TO COUNCIL POLICY 100-06, "CITY COUNCIL FUNDING OF COMMUNITY PROJECTS, PROGRAMS, AND SERVICES."

WHEREAS, the Council of the City of San Diego (City Council) adopted Council Policy 100-06, titled "City Council Funding of Community Projects, Programs and Services" on June 28, 2011, by San Diego Resolution R-306903 (July 7, 2011); and

WHEREAS, among other things, Council Policy 100-06 establishes guidelines and

uniform eligibility requirements for funding Community Projects, Programs, and Services with

non-profit community organizations and public agencies for community, social, environmental,

cultural, or recreational needs which serve a lawful public purpose; and

WHEREAS, the City of San Diego (City) received and evaluated 4 applications for

Community Projects, Programs, and Services funding for the following purposes:

WHEREAS, it is the determination of the City Council that the above-described program fits within the parameters of Council Policy 100-06; and

WHEREAS, Council District 3 recommends an allocation of \$2,000 to Assistance League of Greater San Diego to purchase of uniforms and other apparel for students, as set forth in this resolution; and

WHEREAS, Council District 3 recommends an allocation of \$1,500 to California Western School of Law for personnel and staff costs, coordination of presentations, and advertising and promotion expenses, as set forth in this resolution; and

WHEREAS, Council District 3 recommends an allocation of \$2,500 to Catholic Charities, Diocese of San Diego for shower and laundry facilities, disposable plates, cups, and utensils, cleaning supplies, and water and sewer services, as set forth in this resolution; and

WHEREAS, Council District 3 recommends an allocation of \$2,500 to Episcopal Community Services for linens and other supplies for a residential facility, as set forth in this resolution; and

WHEREAS, the Office of the City Attorney has drafted this resolution based on the information provided by City staff, including information provided by affected third parties and

verified by City staff, with the understanding that this information is complete, true, and accurate; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocations described in this resolution are made for a public purpose.

BE IT FURTHER RESOLVED, that, for Episcopal Community Services, the City Council waives Council Policy 100-06, section 3(g), which provides: "An organization may not apply to receive funding for an event or program which has already occurred, nor any capital improvement, goods, supplies, materials, or equipment which have already been purchased."

BE IT FURTHER RESOLVED, that, for California Western School of Law and Catholic Charities, Diocese of San Diego, the City Council waives Council Policy 100-06, section 8, which provides: "Community Projects, Programs, and Services funding should be considered a one-time resource, and planned uses should be one-time in nature, to avoid service interruptions or employee impacts if funding is discontinued."

BE IT FURTHER RESOLVED, that the Mayor, or their designee, is authorized and directed to execute, for and on behalf of the City, a Community Projects, Programs, and Services FY 2023 City Council Allocations Agreement between the City of San Diego and (1) Assistance League of Greater San Diego in an amount not to exceed \$2,000, (2) California Western School of Law in an amount not to exceed \$1,500, (3) Catholic Charities, Diocese of San Diego, in an amount not to exceed \$2,500, and (4) Episcopal Community Services in an amount not to exceed \$2,500, under the terms and conditions set forth in the Agreements on file in the Office of the City Clerk as Document No. RR-314745 for Assistance League of Greater San Diego, Document No. RR-314745 for California Western School of Law, Document

No. RR-<u>314745</u> for Catholic Charities, Diocese of San Diego, and Document No. RR-<u>314745</u> for Episcopal Community Services.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$8,500 from Council District 3: Community Projects, Programs, and Services budget Fund No. 100000, G/L Account No. 512059, Cost Center 1103110003, all to provide funds for the above-referenced Agreements, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
