A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO CONCURRING WITH THE MAYOR'S
DIRECTION TO CITY STAFF TO EXPEDITIOUSLY
EXPLORE DEVELOPMENT OF THE HOMELESSNESS
RESPONSE CENTER SITE AND THE FORMER CENTRAL
LIBRARY SITE FOR AFFORDABLE HOUSING USES OR
HOMELESS SHELTER USES, OR BOTH.

WHEREAS, the Office of the Mayor has determined that various parcels of City-owned
real property in the Civic Core area of downtown San Diego (collectively, Designated
Properties) are surplus to the City's needs and no longer needed for a municipal use; and

WHEREAS, the Designated Properties include: (a) the City Administration Building site
located at 202 C Street; (b) the Concourse and Golden Hall site located at 1101 First Avenue;
(c) the Evan V. Jones Parkade site located at 1265 First Avenue; (d) the Civic Theater site
located at 1100 Third Avenue; (e) the Civic Center Plaza site located at 1200 Third Avenue, and
the King-Chavez Community High School site located at 201 A Street; and (f) the site located at
101 Ash Street; and

WHEREAS, concurrently with the adoption of this Resolution, the Council of the City of
San Diego (Council) has adopted a resolution declaring the Designated Properties to be "surplus
land" as defined in the California Surplus Land Act (SLA), Government Code sections 54220-
54234, and authorizing and directing the Mayor or designee to issue a notice of availability
(NOA) of the Designated Properties in compliance with the SLA, subject to certain development
conditions; and

WHEREAS, the City's issuance of the NOA is the first step in the City's eventual disposition (sale or lease) of the Designated Properties consistent with the SLA and the development conditions identified in the NOA; and

WHEREAS, it is anticipated that, if the City is able to negotiate the sale or lease of the Designated Properties, the buyer or lessee will demolish various existing buildings and other improvements on the Designated Properties as part of a new development project; and

WHEREAS, if certain existing buildings and other improvements on the Designated Properties are demolished in the future, then the Golden Hall facility will no longer be available for use as a bridge shelter (in the past, that facility has provided up to 324 beds for adults aged 18 or older, up to 46 beds for transitional youth between the ages of 18 and 24, and up to 164 beds and cribs for families with children); and

WHEREAS, the City also owns the following properties in downtown San Diego: (1) the Homelessness Response Center site, located at 1401 Imperial Avenue (HRC Site), where the City provides a broad range of services to help individuals and families experiencing homelessness on their path to permanent or longer-term housing; and (2) the former Central Library site, located at 820 E Street (Former Library Site); and

WHEREAS, in anticipation of the potential future redevelopment of the Designated Properties, the Office of the Mayor directed City staff to expeditiously explore development of affordable housing or homeless shelter uses, or both, on the HRC Site and the Former Library Site; and

WHEREAS, the Office of the City Attorney drafted this Resolution based on the information provided by City staff (including information provided by affected third parties and

verified by City staff), with the understanding that this information is complete, true, and accurate; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Council concurs with the Mayor's direction to City staff to expeditiously explore development of affordable housing or homeless shelter uses, or both, on the HRC Site and the Former Library Site.
