DATE OF FINAL PASSAGE MAY 01 2023

A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO TO ESTABLISH A PART-TIME TOW-AWAY
ZONE ON FIFTH AVENUE BETWEEN BROADWAY AND
K STREET.

WHEREAS, the City of San Diego intends to designate Fifth Avenue as a "slow street" under California Vehicle Code section 21101(f) to include intermittent closures to vehicle traffic; and

WHEREAS, a tow-away zone along the designated "slow street" area of Fifth Avenue, between Broadway and K Street, is necessary to implement the proposed intermittent closures; and

WHEREAS, the intermittent closure to vehicular traffic is intended to occur seven days a week, between the hours of 12 p.m. and 2 a.m.; and

WHEREAS, the proposed tow-away zone will not go into effect until the designation of the "slow street" on Fifth Avenue is effective; and


WHEREAS, tow-away parking restrictions are authorized by San Diego Municipal Code sections 86.0107 and 82.30; and

WHEREAS, the Office of the City Attorney has drafted this resolution based on the information provided by City staff, with the understanding that this information is complete, true, and accurate; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that a tow-away parking zone is established on Fifth Avenue between Broadway and K Street, effective between 12 p.m. and 2 a.m. every day of the week.

BE IT FURTHER RESOLVED, implementation of the tow-away parking zone is contingent upon the approval of an ordinance to designate Fifth Avenue as a "slow street," and will not take effect until the "slow street" designation is effective.
