DATE OF FINAL PASSAGE **APR 25 2023**

A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO ADOPTING AN AMENDED CONFLICT OF
INTEREST CODE FOR THE FINANCE DEPARTMENT.

WHEREAS, California Government Code (Government Code) sections 87300 and 87302 require local agencies to adopt conflict of interest codes designating positions that involve the making or participation in making of decisions which may foreseeably have a material effect on financial interests, and for each position, the financial interests which are reportable; and

WHEREAS, in compliance with the Government Code, the Council of the City of San Diego (City Council) serves as the code-reviewing body for City departments, agencies, boards and commissions, and entities that it has created; and

WHEREAS, as the City's code-reviewing body, the City Council finds it in the public interest to adopt the standard conflict of interest code promulgated by the California Fair Political Practices Commission (FPPC) in Regulation 18730, and hereby declares its intention to incorporate by reference the terms of FPPC Regulation 18730, and any amendments to that regulation duly adopted by the FPPC, as part of each conflict of interest code for which the City Council has responsibility; and

WHEREAS, by Resolution No. R-313327 (Nov. 17, 2020), the City Council approved an amended Conflict of Interest Code for the Finance Department; and

WHEREAS, the City Council adopted San Diego Ordinance O-21565 (Nov. 3, 2022) to consolidate the Debt Management Department as a division of the Finance Department for consistency and streamlining of the financial disclosure preparation process and greater integration of the debt function with long-term financial planning of the Capital Improvement

Program, improve coordination and collaboration as the City's financing, budgeting, and accounting functions are consolidated within one centralized department, and other efficiencies; and

WHEREAS, the Finance Department now seeks to amend its conflict of interest code to add new positions for the consolidated Debt Management Division, all as detailed in Appendix A; and

WHEREAS, the Office of the City Attorney has drafted this resolution based on the information provided by City staff, with the understanding that this information is complete, true, and accurate; and

WHEREAS, Government Code section 87303 provides that when a proposed conflict of interest code or amendment is approved by the code-reviewing body, it shall be deemed adopted, and, accordingly, this resolution is not subject to veto by the Mayor; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that a Conflict of Interest Code for the Finance Department is hereby adopted, consisting of standard language embodied in title 2, section 18730 of the California Code of Regulations, and any amendments to that regulation duly adopted by the Fair Political Practices Commission, with Appendix A showing designated positions and their duties, and Appendix B showing the disclosure categories.

BE IT FURTHER RESOLVED, that a copy of Appendix A and Appendix B to the Conflict of Interest Code for the Finance Department as adopted be placed on file in the Office of the City Clerk as Document No. RR-**314771**.

BE IT FURTHER RESOLVED, that the persons whose positions are designated in the Conflict of Interest Code for the Finance Department shall file their statements of economic interest with the City Clerk in compliance with the schedule set forth in Government Code

section 87302(b) and Fair Political Practices Commission Regulation 18730, or any amendments thereto, which set forth the deadlines for the filing of initial statements, assuming office statements, annual statements, and leaving office statements.



BE IT FURTHER RESOLVED, that the Conflict of Interest Code for the Finance Department becomes effective upon the date of adoption of this resolution.

BE IT FURTHER RESOLVED, that the Conflict of Interest Code for the Debt Management Department will no longer exist upon the adoption of this resolution.
