A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO APPROVING THE SETTLEMENT AGREEMENT
BETWEEN STEPHANIE SKEES AND THE CITY OF SAN
DIEGO

WHEREAS, on March 21, 2019, Stephanie Skees filed suit against the City of San Diego alleging personal injuries arising from a September 22, 2018 bicycle accident in the bike lane on southbound North Harbor Drive in the City of San Diego. The suit is captioned *Stephanie Skees v. City of San Diego*, San Diego Superior Court Case No. 37-2020-00016673-CU-PO-CTL; and,

WHEREAS, in Closed Session on March 13, 2023, the City Council by the following votes: Yea, Districts 1, 2, 3, 4, 5, 6, 7, 8, and 9; Nays, None; approved the settlement for an amount consistent with the amounts set forth below; NOW, THEREFORE,


BE IT RESOLVED, by the Council of the City of San Diego, that the Council:

1. Authorizes the Mayor or his designee to pay the sum of \$90,000.00 from Public Liability Fund No. 720045, in settlement of each and every claim for damages, interest, costs and fees of any type, including attorney fees, against the City of San Diego, its agents and employees, arising from the personal injury complaint filed by Plaintiff Stephanie Skees.

2. Authorizes the Chief Financial Officer to expend \$90,000.00 from Public Liability Fund No. 720045 for the purpose of settling this claim.
