A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING COMMUNITY PROJECTS, PROGRAMS, AND SERVICES FUNDING TO PACIFIC ARTS MOVEMENT, PURSUANT TO COUNCIL POLICY 100-06, AND AUTHORIZING EXECUTION OF AN ALLOCATIONS AGREEMENT; AND ALLOCATING ARTS, CULTURE, AND COMMUNITY FESTIVAL FUNDING, PURSUANT TO COUNCIL POLICY 100-23, TO AUGMENT PACIFIC ARTS MOVEMENT'S EXISTING CONTRACT WITH THE CITY OF SAN DIEGO'S COMMISSION FOR ARTS AND CULTURE.

WHEREAS, the Council of the City of San Diego (City Council) adopted Council Policy 100-06, titled "City Council Funding of Community Projects, Programs and Services" on July 7, 2011, by San Diego Resolution R-306903; and

WHEREAS, among other things, Council Policy 100-06 establishes guidelines and uniform eligibility requirements for funding Community Projects, Programs, and Services (CPPS) with non-profit community organizations and public agencies for community, social,

environmental, cultural, or recreational needs which serve a lawful public purpose; and

WHEREAS, Pacific Arts Movement has requested CPPS funding for operating support;

and

WHEREAS, the requested CPPS funding will be used for program staff salaries, rent,

utilities, and office supplies; and

WHEREAS, Pacific Arts Movement's request for CPPS funding for operating support will benefit the public by allowing the organization to continue to showcase cultural acheivements and build compassionate community networks; and

WHEREAS, it is the determination of the City Council that the above-described use of CPPS funds is consistent with Council Policy 100-06; and

WHEREAS, Council Districts 1, 2, 3, 5, 6, 7 and 8 recommend a total allocation of \$33,000 in CPPS funds to the Pacific Arts Movement for the purposes set forth in this resolution, attributed as follows: Council District 1 – \$3,000; Council District 2 – \$5,000; Council District 3 – \$1,500; Council District 5 – \$2,000; Council District 6 – \$15,000; Council District 7 –\$1,500; and Council District 8 – \$5,000; and

WHEREAS, City Council adopted Council Policy 100-23, titled "City Council Funding of Arts, Culture and Community Festivals with Discretionary Transient Occupancy Tax Allocations," on August 13, 2012, by San Diego Resolution R-307625; and

WHEREAS, among other things, Council Policy 100-23 establishes uniform guidelines, conditions, and criteria governing the application for, and granting of, funds to non-profit organizations for the purpose of supporting their ongoing operational expenses and their sponsorship of special events at the discretion of each Council District during the fiscal year; and

WHEREAS, funding for Arts, Culture and Community Festivals (ACCF) from each Council District's annual allocation of Transient Occupancy Tax (TOT) may be awarded to private non-profit organizations that produce programs, projects, and events that provide access to excellence in culture and the arts for residents of, and visitors to, the City, and enrich the lives of the people of San Diego and build healthy, vital neighborhoods; and

WHEREAS, Council Policy 100-23 requires each grant of ACCF funding to a private non-profit organization be done by City Council resolution; and

WHEREAS, Council Districts 1, 2, 4, and 6 recommend a total allocation of ACCF funds in an amount not to exceed \$28,500 (Attachment 1), attributed as follows: Council District 1 – \$3,500; Council District 2 – \$5,000; Council District 4 – \$5,000; and Council District 6 – \$15,000; and

WHEREAS, Pacific Arts Movement and the City have an existing contract administered by the City's Commission for Arts and Culture; and

WHEREAS, rather than executing a new contract, the City's Commission for Arts and Culture may amend the existing contract between the City and Pacific Arts Movement to include the recommended ACCF allocations from each Council District; and

WHEREAS, it is the determination of the City Council that the use of ACCF funds is consistent with Council Policy 100-23; and

WHEREAS, the Office of the City Attorney has drafted this resolution based on the information provided by City staff, including information provided by affected third parties and verified by City staff, with the understanding that this information is complete, true, and accurate; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the funding allocations described in this resolution are made for a public purpose.

BE IT FURTHER RESOLVED, City Council waives provisions in Council Policy 100-06 prohibiting allocation of CPPS funds to an event or program that has already occurred or capital improvement, goods, supplies, materials, or equipment that have already been purchased.

BE IT FURTHER RESOLVED, that the Mayor, or designee, is authorized and directed to execute, for and on behalf of the City of San Diego (City), a Community Projects, Programs, and Services FY 2023 City Council Allocations Agreement between the City and the Pacific Arts Movement (Agreement) in an amount not to exceed \$33,000 for the project, program, or services described in this resolution, under terms and conditions set forth in the Agreement on file in the Office of the City Clerk as Document No. RR-**314821**___.
