A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING A SIDE LETTER AGREEMENT BETWEEN THE CITY AND THE CALIFORNIA TEAMSTERS, LOCAL 911, TO AMEND ARTICLE 45 OF THE MEMORANDUM OF UNDERSTANDING RELATED TO CITY HOLIDAYS.

WHEREAS, by San Diego Resolution R-314186 (June 23, 2022), the San Diego City Council (Council) approved a Memorandum of Understanding (MOU) between the City of San Diego (City) and the California Teamsters Local 911 (Local 911) regarding terms and conditions of employment for employees represented by Local 911 for fiscal years 2023 and 2024; and

WHEREAS, Article 45 of the MOU lists the City's holidays, which are set forth under San Diego Municipal Code section 21.0104; and

WHEREAS, by San Diego Ordinance O-21635 (April 24, 2023), the Council amended Municipal Code section 21.0104 to establish June 19, known as Juneteenth, as a City holiday; and

WHEREAS, the City met and conferred with Local 911 and entered into a side letter agreement (Agreement) to amend Article 45 of the MOU to add Juneteenth to the list of City holidays; and

WHEREAS, the Agreement must be approved by a two-thirds majority vote of the Council to take effect, in accordance with Charter section 11.2; and

WHEREAS, the Office of the City Attorney has drafted this resolution based on the information provided by City staff, including information provided by affected third parties and verified by City staff, with the understanding that this information is complete, true, and accurate; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Agreement between the City and Local 911 to amend Article 45 of the MOU to add Juneteenth to the list of City holidays, presented to the Council and on file in the Office of the City Clerk as Document No. RR-314835, is approved, and takes effect upon the date of final passage of this Resolution.
