WHEREAS, by San Diego Resolution R-313568 (June 11, 2021), the San Diego City Council (Council) approved a Memorandum of Understanding (MOU) between the City of San Diego (City) and the San Diego Municipal Employees Association (MEA) regarding terms and conditions of employment for employees represented by MEA for fiscal years 2022 and 2023; and

WHEREAS, Article 47 of the MOU lists the City's holidays, which are set forth under San Diego Municipal Code section 21.0104; and

WHEREAS, by San Diego Ordinance O-21635 (April 24, 2023), the Council amended Municipal Code section 21.0104 to establish June 19, known as Juneteenth, as a City holiday; and

WHEREAS, the City met and conferred with MEA and entered into a side letter agreement (Agreement) to amend Article 47 of the MOU to add Juneteenth to the list of City holidays; and

WHEREAS, the Agreement must be approved by a two-thirds majority vote of the Council to take effect, in accordance with Charter section 11.2; and

WHEREAS, the Office of the City Attorney has drafted this resolution based on the information provided by City staff, including information provided by affected third parties and verified by City staff, with the understanding that this information is complete, true, and accurate; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Agreement between the City and MEA to amend Article 47 of the MOU to add Juneteenth to the list of City holidays, presented to the Council and on file in the Office of the City Clerk as Document No.
