DATE OF FINAL PASSAGE MAY 23 2023

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING FUNDS TO CITY HEIGHTS COMMUNITY DEVELOPMENT CORPORATION, COLLEGE AREA ECONOMIC DEVELOPMENT CORPORATION, AND THE GLOBAL ACTION RESEARCH CENTER, PURSUANT TO COUNCIL POLICY 100-06, "CITY COUNCIL FUNDING OF COMMUNITY PROJECTS, PROGRAMS, AND SERVICES."

WHEREAS, the Council of the City of San Diego (City Council) adopted Council Policy 100-06, titled "City Council Funding of Community Projects, Programs and Services" on June 28, 2011, by San Diego Resolution R-306903 (July 7, 2011); and

WHEREAS, among other things, Council Policy 100-06 establishes guidelines and uniform eligibility requirements for funding Community Projects, Programs, and Services with non-profit community organizations and public agencies for community, social, environmental, cultural, or recreational needs which serve a lawful public purpose; and

WHEREAS, the City of San Diego (City) received and evaluated 3 applications for Community Projects, Programs, and Services funding for the following purposes:

ORGANIZATION	PROGRAM/ACTIVITY	PUBLIC BENEFIT
City Heights Community Development Corporation	One Month Away, Emergency Rental Assistance Program	The allocation will benefit the public by preventing eviction among vulnerable San Diego residents to avoid homelessness.
College Area Economic Development Corporation	Special Event Hosting	The allocation will benefit the public by assisting the organization with hosting free community programming.

ORGANIZATION	PROGRAM/ACTIVITY	PUBLIC BENEFIT
The Global Action Research Center	City Heights Village	The allocation will benefit the public by fostering an active environment for seniors so that they may remain healthy.

WHEREAS, it is the determination of the City Council that the above-described program fits within the parameters of Council Policy 100-06; and

WHEREAS, Council District 9 recommends an allocation of \$15,000 to City Heights Community Development Corporation for emergency rental assistance payments, as set forth in this resolution; and

WHEREAS, Council District 9 recommends an allocation of \$10,000 to College Area Economic Development Corporation to assist the organization in hosting free, public social events by providing funding for payroll, rent, utilities, and marketing efforts, as set forth in this resolution; and

WHEREAS, Council District 9 recommends an allocation of \$5,000 to The Global Action Research Center for personnel expenses, translation services, rental expenses, and materials and equipment to support a meeting space and cross-cultural events, as set forth in this resolution; and

WHEREAS, the Office of the City Attorney has drafted this resolution based on the information provided by City staff, including information provided by affected third parties and verified by City staff, with the understanding that this information is complete, true, and accurate; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocations described in this resolution are made for a public purpose.

BE IT FURTHER RESOLVED, that, for City Heights Community Development Corporation, the City Council waives Council Policy 100-06, section 3(g), which provides: "An organization may not apply to receive funding for an event or program which has already occurred, nor any capital improvement, goods, supplies, materials, or equipment which have already been purchased."

BE IT FURTHER RESOLVED, that, for College Area Economic Development Corporation and The Global Action Research Center, the City Council waives Council Policy 100-06, section 8, which provides: "Community Projects, Programs, and Services funding should be considered a one-time resource, and planned uses should be one-time in nature, to avoid service interruptions or employee impacts if funding is discontinued."

BE IT FURTHER RESOLVED, that the Mayor, or their designee, is authorized and directed to execute, for and on behalf of the City, a Community Projects, Programs, and Services FY 2023 City Council Allocations Agreement between the City of San Diego and (1) City Heights Community Development Corporation in an amount not to exceed \$15,000, (2) College Area Economic Development Corporation in an amount not to exceed \$10,000, and (3) The Global Action Research Center in an amount not to exceed \$5,000, under the terms and conditions set forth in the Agreements on file in the Office of the City Clerk as Document No. RR- 314838-1 for City Heights Community Development Corporation, Document No. RR- 314838-2 for College Area Economic Development Corporation, and Document No. RR- 314838-3 for The Global Action Research Center.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$30,000 from Council District 9: Community Projects, Programs, and Services budget Fund No. 100000, G/L Account No. 512059, Cost Center 1109110009, all to provide funds for the above-referenced Agreements, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
