A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING FUNDS FOR ARTS, CULTURE, AND COMMUNITY FESTIVALS TO TRANSFAMILY SUPPORT SERVICES FOR TFSS FAMILY PROGRAMMING OUTREACH, PURSUANT TO COUNCIL POLICY 100-23, "CITY COUNCIL FUNDING OF ARTS, CULTURE AND COMMUNITY FESTIVALS WITH DISCRETIONARY TRANSIENT OCCUPANCY TAX ALLOCATION."

WHEREAS, the Council of the City of San Diego (City Council) adopted Council Policy 100-23, titled "City Council Funding of Arts, Culture and Community Festivals with Discretionary Transient Occupancy Tax Allocation" on August 13, 2012, by San Diego Resolution R-307625 (August 13, 2012); and

WHEREAS, Council Policy 100-23 provides a procedure and uniform requirements for awarding funds to and contracting with private non-profit organizations that produce programs, projects, and events that (i) provide access to excellence in culture and the arts for residents of, and visitors to, the City of San Diego (City), and (ii) enrich the lives of the people of the City and build healthy, vital neighborhoods; and

WHEREAS, TransFamily Support Services has requested funding for TFSS Family Programming Outreach; and

WHEREAS, the requested funding will be used for staging, sound, performer fees, photography, security, decorations, marketing, personnel expenses, games, and activities; and

WHEREAS, TransFamily Support Services' request for funding for TFSS Family Programming Outreach will benefit the public by promoting knowledge and familiarity of San Diego's transgender community and increasing transgender youth safety; and

WHEREAS, it is the determination of the City Council that the above-described program is consistent with Council Policy 100-23; and

WHEREAS, Council Districts 2, 3, and 7 recommend a total allocation of \$9,000 to TransFamily Support Services for the purposes set forth in this resolution, attributed as follows: Council District 2 – \$3,000; Council District 3 – \$4,000; and Council District 7 –\$2,000; and

WHEREAS, the Office of the City Attorney has drafted this resolution based on the information provided by City staff, including information provided by affected third parties and verified by City staff, with the understanding that this information is complete, true, and accurate; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocations described in this resolution are made for a public purpose.

BE IT FURTHER RESOLVED, that the City Council waives Council Policy 100-23, section 2(g), which provides: “An organization may not apply to receive funding for an event or program which has already occurred, nor any goods, supplies or materials which have already been purchased.”


BE IT FURTHER RESOLVED, that the Mayor, or designee, is authorized and directed to execute, for and on behalf of the City, the Arts, Culture, and Community Festivals Fiscal Year 2023 City Council Allocations Grant Agreement between the City of San Diego and TransFamily Support Services (Agreement) in an amount not to exceed \$9,000, under the terms and conditions set forth in the Agreement on file in the Office of the City Clerk as Document No.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$3,000 from Council District 2: TOT Fund No. 200205, G/L Account No. 512059, Cost Center 141411213; \$4,000 from Council District 3: TOT Fund No. 200205,

G/L Account No. 512059, Cost Center 1414111214; and \$2,000 from Council District 7: TOT Fund No. 200205, G/L Account No. 512059, Cost Center 1414111218, for a total of \$9,000, all to provide funds for the above-referenced Agreement, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.


