A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING FUNDS TO ALL FOR LOGAN; CENTRO DE SALUD DE LA COMUNIDAD DE SAN YSIDRO, INC.; DBA SAN YSIDRO HEALTH; CHICANO FEDERATION OF SAN DIEGO COUNTY; CHICANO PARK MUSEUM AND CULTURAL CENTER; AND CITY BALLET INC., PURSUANT TO COUNCIL POLICY 100-06, "CITY COUNCIL FUNDING OF COMMUNITY PROJECTS, PROGRAMS, AND SERVICES."

WHEREAS, the Council of the City of San Diego (City Council) adopted Council Policy 100-06, titled "City Council Funding of Community Projects, Programs and Services" on June 28, 2011, by San Diego Resolution R-306903 (July 7, 2011); and

WHEREAS, among other things, Council Policy 100-06 establishes guidelines and uniform eligibility requirements for funding Community Projects, Programs, and Services with non-profit community organizations and public agencies for community, social, environmental, cultural, or recreational needs which serve a lawful public purpose; and

WHEREAS, the City of San Diego (City) received and evaluated five applications for Community Projects, Programs, and Services funding for the following purposes:

WHEREAS, it is the determination of the City Council that the above-described program fits within the parameters of Council Policy 100-06; and

WHEREAS, Council District 8 recommends an allocation of \$10,000 to All for Logan for trash receptacles, trash bags, and marketing materials, as set forth in this resolution; and

WHEREAS, Council District 8 recommends an allocation of \$8,000 to Centro De Salud de la Comunidad De San Ysidro, Inc., DBA San Ysidro Health, for four vital sign equipment stations for clinic sites, as set forth in this resolution; and

WHEREAS, Council District 8 recommends an allocation of \$10,000 to Chicano Federation of San Diego County for distribution drive items including clothing, diapers, menstrual supplies, and school supplies, as set forth in this resolution; and

WHEREAS, Council District 8 recommends an allocation of \$10,000 to Chicano Park Museum and Cultural Center for artist fees and website development costs, as set forth in this resolution; and

WHEREAS, Council District 8 recommends an allocation of \$2,000 to City Ballet Inc., for instructor fees, dance uniforms, and classroom rental fees, as set forth in this resolution; and

WHEREAS, the Office of the City Attorney has drafted this resolution based on the information provided by City staff, including information provided by affected third parties and verified by City staff, with the understanding that this information is complete, true, and accurate; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocations described in this resolution are made for a public purpose.

BE IT FURTHER RESOLVED, that the Mayor, or their designee, is authorized and directed to execute, for and on behalf of the City, a Community Projects, Programs, and Services FY 2023 City Council Allocations Agreement between the City of San Diego and (1) All for Logan in an amount not to exceed \$10,000, (2) Centro de Salud de la Comunidad de San Ysidro, Inc. dba San Ysidro Health in an amount not to exceed \$8,000, (3) Chicano Federation of San Diego County in an amount not to exceed \$10,000, (4) Chicano Park Museum and Cultural Center in an amount not to exceed \$10,000, and (5) City Ballet Inc., in an amount not to exceed \$2,000, under the terms and conditions set forth in the Agreements on file in the Office of the City Clerk as Document No. RR-314855-1 for All for Logan, Document No. RR-314855-3 for Centro de Salud de la Comunidad de San Ysidro, Inc. dba San Ysidro Health, Document No. RR-314855-4 for Chicano Federation of San Diego County, Document No. RR-314855-5 for Chicano Park Museum and Cultural Center, and Document No. RR-314855-5 for City Ballet Inc.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$40,000 from Council District 8: Community Projects, Programs, and

Services budget Fund No. 100000, G/L Account No. 512059, Cost Center 1108110008, all to provide funds for the above-referenced Agreements, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
