A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING FUNDS TO GREATER LIFE BAPTIST CHURCH, MANDATE PROJECT IMPACT, INC., OPEN HEART LEADERS, PROJECT NEW VILLAGE, AND SAN DIEGO COLLEGE OF CONTINUING EDUCATION FOUNDATION, PURSUANT TO COUNCIL POLICY 100-06, "CITY COUNCIL FUNDING OF COMMUNITY PROJECTS, PROGRAMS, AND SERVICES."

WHEREAS, the Council of the City of San Diego (City Council) adopted Council Policy 100-06, titled "City Council Funding of Community Projects, Programs and Services" on June 28, 2011, by San Diego Resolution R-306903 (July 7, 2011); and

WHEREAS, among other things, Council Policy 100-06 establishes guidelines and uniform eligibility requirements for funding Community Projects, Programs, and Services with non-profit community organizations and public agencies for community, social, environmental, cultural, or recreational needs which serve a lawful public purpose; and

WHEREAS, the City of San Diego (City) received and evaluated five applications for Community Projects, Programs, and Services funding for the following purposes:

WHEREAS, it is the determination of the City Council that the above-described program fits within the parameters of Council Policy 100-06; and

WHEREAS, Council District 4 recommends an allocation of \$10,000 to Greater Life
Baptist Church for a commercial refrigerator and freezer, cleaning supplies, and safety
equipment, as set forth in this resolution; and

WHEREAS, Council District 4 recommends an allocation of \$5,000 to Mandate Project Impact, Inc., for film equipment (cameras, microphones, headsets, and protective gear), as set forth in this resolution; and

WHEREAS, Council District 4 recommends an allocation of \$5,000 to Open Heart Leaders for training courses, language workbook materials, office laptops, data management software, and other office supplies, as set forth in this resolution; and

WHEREAS, Council District 4 recommends an allocation of \$10,000 to Project New Village for permit fees and design costs, as set forth in this resolution; and

WHEREAS, Council District 4 recommends an allocation of \$5,000 to San Diego College of Continuing Education Foundation for book publishing fees, as set forth in this resolution; and

WHEREAS, the Office of the City Attorney has drafted this resolution based on the information provided by City staff, including information provided by affected third parties and verified by City staff, with the understanding that this information is complete, true, and accurate; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocations described in this resolution are made for a public purpose.

BE IT FURTHER RESOLVED, that the Mayor, or their designee, is authorized and directed to execute, for and on behalf of the City, a Community Projects, Programs, and Services FY 2023 City Council Allocations Agreement between the City of San Diego and (1) Greater Life Baptist Church in an amount not to exceed \$10,000, (2) Mandate Project Impact, Inc., in an amount not to exceed \$5,000, (3) Open Heart Leaders in an amount not to exceed \$5,000, (4) Project New Village in an amount not to exceed \$10,000, and (5) San Diego College of Continuing Education Foundation in an amount not to exceed \$5,000, under the terms and conditions set forth in the Agreements on file in the Office of the City Clerk as Document No.

Services budget Fund No. 100000, G/L Account No. 512059, Cost Center 1104110004, all to provide funds for the above-referenced Agreements, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
