SAN DIEGO APPROVING THE SETTLEMENT AGREEMENT  
BETWEEN JOAN VANDERSCHUIT AND THE CITY OF SAN  
DIEGO

WHEREAS, on November 9, 2021, Joan Vanderschuit filed suit against the City of San Diego alleging personal injury arising from the October 3, 2020, electric bicycle accident on an unmarked speed bump. The lawsuit is titled *Joan Vanderschuit v. City of San Diego, et al.*, San Diego Superior Court Case No. 37-2021-00047593-CU-PO-CTL (Litigation); and

WHEREAS, in Closed Session on April 10, 2023, by the following votes: Yeas, Districts 1, 2, 3, 4, 5, 6, 7, 8, and 9; Nays, none; and Absent, none; approved the Settlement of the Litigation for an amount consistent with the amounts set forth below; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Council:

1. Authorizes the Mayor or his designee to pay the sum of \$150,000.00 from Public Liability Fund No. 720045, in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorney fees, against the City of San Diego, its agents and employees, arising from the Litigation.

2. Authorizes the Chief Financial Officer to expend an amount not to exceed \$150,000.00 from Public Liability Fund No. 720045, for the purpose of settling the Litigation.




