WHEREAS, the Commission conducts hearings on all special use permits, all re-zonings, all community plans and the General Plan, and considers land use ordinances and other improvements as the Council of the City of San Diego (Council) may, by ordinance, determine; and

WHEREAS, the Commission consists of seven members appointed by the Mayor, subject to Council confirmation; and

WHEREAS, members of the Commission serve four-year terms and until their successors are appointed, confirmed, and qualified; and


WHEREAS, appointments to the Commission are to be made so that not more than three members are appointed in any one year; and




