A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING FUNDS TO PARENT INSTITUTE FOR QUALITY EDUCATION FOR PIQE FAMILY ENGAGEMENT IN EDUCATION; SAN DIEGO CIVIC YOUTH BALLET FOR COMMUNITY OUTREACH PROGRAMS; SAN YSIDRO IMPROVEMENT CORPORATION FOR SMALL BUSINESS TECHNICAL ASSISTANCE; SHERMAN HEIGHTS COMMUNITY CENTER FOR ENGLISH AS A SECOND LANGUAGE CLASSES; AND SHERMAN HEIGHTS COMMUNITY CENTER FOR HEALTHY PARENTING AND DOMESTIC VIOLENCE MEDIATION CLASSES, PURSUANT TO COUNCIL POLICY 100-06, "CITY COUNCIL FUNDING OF COMMUNITY PROJECTS, PROGRAMS, AND SERVICES."

WHEREAS, the Council of the City of San Diego (City Council) adopted Council Policy 100-06, titled "City Council Funding of Community Projects, Programs and Services" on June 28, 2011, by San Diego Resolution R-306903 (July 7, 2011); and

WHEREAS, among other things, Council Policy 100-06 establishes guidelines and uniform eligibility requirements for funding Community Projects, Programs, and Services with non-profit community organizations and public agencies for community, social, environmental, cultural, or recreational needs which serve a lawful public purpose; and

WHEREAS, the City of San Diego (City) received and evaluated five applications for Community Projects, Programs, and Services funding for the following purposes:

WHEREAS, it is the determination of the City Council that the above-described program fits within the parameters of Council Policy 100-06; and

WHEREAS, Council District 8 recommends an allocation of \$5,000 to Parent Institute for Quality Education for payroll expenses, online subscriptions, and other office utility fees, as set forth in this resolution; and

WHEREAS, Council District 8 recommends an allocation of \$2,500 to San Diego Civic Youth for personnel, dance program materials, and costumes, as set forth in this resolution; and

WHEREAS, Council District 8 recommends an allocation of \$10,000 to San Ysidro

Improvement Corporation for staff time, office equipment, and program supplies, as set forth in this resolution; and

WHEREAS, Council District 8 recommends an allocation of \$2,500 to Sherman Heights

Community Center for classroom supplies, marketing and outreach supplies, and personnel

expenses, as set forth in this resolution; and

WHEREAS, Council District 8 recommends an allocation of \$2,500 to Sherman Heights

Community Center for Office supplies, printing and marketing costs, and staff wages, as set forth
in this resolution; and

WHEREAS, the Office of the City Attorney has drafted this resolution based on the information provided by City staff, including information provided by affected third parties and verified by City staff, with the understanding that this information is complete, true, and accurate; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocations described in this resolution are made for a public purpose.

BE IT FURTHER RESOLVED, that, for Parent Institute for Quality Education, San Diego Civic Youth Ballet, San Ysidro Improvement Corporation, and Sherman Heights Community Center, the City Council waives Council Policy 100-06, section 8, which provides: "Community Projects, Programs, and Services funding should be considered a one-time resource, and planned uses should be one-time in nature, to avoid service interruptions or employee impacts if funding is discontinued."

BE IT FURTHER RESOLVED, that the Mayor, or their designee, is authorized and directed to execute, for and on behalf of the City, a Community Projects, Programs, and Services FY 2023 City Council Allocations Agreement between the City of San Diego and (1) Parent Institute for Quality Education in an amount not to exceed \$5,000, (2) San Diego Civic Youth Ballet in an amount not to exceed \$2,500, (3) San Ysidro Improvement Corporation in an amount not to exceed \$10,000, (4) Sherman Heights Community Center in an amount not to exceed \$2,500, and (5) Sherman Heights Community Center in an amount not to exceed \$2,500, under the terms and conditions set forth in the Agreements on file in the Office of the City Clerk as Document No. RR
314882.1 for Parent Institute for Quality Education,
Document No. RR
314882.2 for San Diego Civic Youth Ballet, Document

No. RR 314882.4 for Sherman Heights Community Center, and Document

No. RR 314882.5 for Sherman Heights Community Center.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$22,500 from Council District 8: Community Projects, Programs, and Services budget Fund No. 100000, G/L Account No. 512059, Cost Center 1108110008, all to provide funds for the above-referenced Agreements, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
