A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING FUNDS TO ENVIRONMENTAL HEALTH COALITION; GROUNDWORK SAN DIEGO CHOLLAS CREEK; OTAY MESA CHAMBER OF COMMERCE; REBUILDING TOGETHER SAN DIEGO; AND SAN DIEGO COUNTY IMPERIAL VALLEY HISPANIC CHAMBER OF COMMERCE, PURSUANT TO COUNCIL POLICY 100-06, "CITY COUNCIL FUNDING OF COMMUNITY PROJECTS, PROGRAMS, AND SERVICES."

WHEREAS, the Council of the City of San Diego (City Council) adopted Council Policy 100-06, titled "City Council Funding of Community Projects, Programs and Services" on June 28, 2011, by San Diego Resolution R-306903 (July 7, 2011); and

WHEREAS, among other things, Council Policy 100-06 establishes guidelines and uniform eligibility requirements for funding Community Projects, Programs, and Services with non-profit community organizations and public agencies for community, social, environmental, cultural, or recreational needs which serve a lawful public purpose; and

WHEREAS, the City of San Diego (City) received and evaluated five applications for Community Projects, Programs, and Services funding for the following purposes:

WHEREAS, it is the determination of the City Council that the above-described program fits within the parameters of Council Policy 100-06; and

WHEREAS, Council District 8 recommends an allocation of \$5,000 to Environmental Health Coalition for staff time, as set forth in this resolution; and

WHEREAS, Council District 8 recommends an allocation of \$5,000 to Groundwork San Diego Chollas Creek to remove non-native vegetation from residential yards adjacent to Chollas Creek, as set forth in this resolution; and

WHEREAS, Council District 8 recommends an allocation of \$5,000 to Otay Mesa Chamber of Commerce for contractor fees for Adopt a Highway, printing expenses, and IT support services, as set forth in this resolution; and

WHEREAS, Council District 8 recommends an allocation of \$5,000 to to Rebuilding Together San Diego for office equipment including a copier, printer, desks, computers, file cabinets, paper, and toner, as set forth in this resolution; and

WHEREAS, Council District 8 recommends an allocation of \$5,000 to San Diego County Imperial Valley Hispanic Chamber of Commerce for QuickBooks training, business licensing costs, and other business-related support, as set forth in this resolution; and

WHEREAS, the Office of the City Attorney has drafted this resolution based on the information provided by City staff, including information provided by affected third parties and

verified by City staff, with the understanding that this information is complete, true, and accurate; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocations described in this resolution are made for a public purpose.

BE IT FURTHER RESOL VED, that the Mayor, or their designee, is authorized and directed to execute, for and on behalf of the City, a Community Projects, Programs, and Services FY 2023 City Council Allocations Agreement between the City of San Diego and (1)

Environmental Health Coalition in an amount not to exceed \$5,000, (2) Groundwork San Diego Chollas Creek in an amount not to exceed \$5,000, (3) Otay Mesa Chamber of Commerce in an amount not to exceed \$5,000, (4) Rebuilding Together San Diego in an amount not to exceed \$5,000, and (5) San Diego County Imperial Valley Hispanic Chamber of Commerce in an amount not to exceed \$5,000, under the terms and conditions set forth in the Agreements on file in the Office of the City Clerk as Document No. RR-314883. for Groundwork San Diego Chollas Creek, Document No. RR-314883. for Otay Mesa Chamber of Commerce, Document No. RR-314883. for Rebuilding Together San Diego, and Document No. RR-314883. for San Diego County Imperial Valley Hispanic Chamber of Commerce.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$25,000 from Council District 8: Community Projects, Programs, and Services budget Fund No. 100000, G/L Account No. 512059, Cost Center 1108110008, all to provide funds for the above-referenced Agreements, contingent upon the Chief Financial Officer

first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
