A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING FUNDS TO SPACE 4 ART, INC.; YMCA OF SAN DIEGO COUNTY, BORDER VIEW FAMILY YMCA; SAN DIEGO THERAPEUTIC HORSEMANSHIP; AND SAN DIEGO OPERA ASSOCIATION, PURSUANT TO COUNCIL POLICY 100-06, "CITY COUNCIL FUNDING OF COMMUNITY PROJECTS, PROGRAMS, AND SERVICES."

WHEREAS, the Council of the City of San Diego (City Council) adopted Council Policy 100-06, titled "City Council Funding of Community Projects, Programs and Services" on June 28, 2011, by San Diego Resolution R-306903 (July 7, 2011); and

WHEREAS, among other things, Council Policy 100-06 establishes guidelines and uniform eligibility requirements for funding Community Projects, Programs, and Services with non-profit community organizations and public agencies for community, social, environmental, cultural, or recreational needs which serve a lawful public purpose; and

WHEREAS, the City of San Diego (City) received and evaluated four applications for Community Projects, Programs, and Services funding for the following purposes:

Space 4 Art, Inc.	Weed Abatement	Beautifies the community.
YMCA of San Diego County, Border View Family YMCA (YMCA of San Diego County)	Teen Wellness Program	Provides academic support to teens in San Ysidro.
San Diego Therapeutic Horsemanship	Horses and Joining Together	Provides educational opportunities to students.
San Diego Opera Association	LED Supertitle Screen for English and Spanish Language	Closes the cultural divide.

WHEREAS, it is the determination of the City Council that the above-described program fits within the parameters of Council Policy 100-06; and

WHEREAS, Council District 8 recommends an allocation of \$2,200 to Space 4 Art, Inc. for weed abatement, debris removal, and graffiti removal, as set forth in this resolution; and

WHEREAS, Council District 8 recommends an allocation of \$5,000 to YMCA of San Diego County for software licensing fees, program staff salaries, and fitness activity supplies, as set forth in this resolution; and

WHEREAS, Council District 8 recommends an allocation of \$3,000 to San Diego
Therapeutic Horsemanship for art supplies and program personnel costs, as set forth in this
resolution; and

WHEREAS, Council District 8 recommends an allocation of \$3,000 to San Diego Opera Association for an LED supertitle screen and installation, as set forth in this resolution; and

WHEREAS, the Office of the City Attorney has drafted this resolution based on the information provided by City staff, including information provided by affected third parties and verified by City staff, with the understanding that this information is complete, true, and accurate; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocations described in this resolution are made for a public purpose.

BE IT FURTHER RESOLVED, that, for Space 4 Art, Inc. and YMCA of San Diego County, the City Council waives Council Policy 100-06, section 8, which provides: "Community Projects, Programs, and Services funding should be considered a one-time resource, and planned uses should be one-time in nature, to avoid service interruptions or employee impacts if funding is discontinued."

BE IT FURTHER RESOLVED, that the Mayor, or their designee, is authorized and directed to execute, for and on behalf of the City, a Community Projects, Programs, and Services FY 2023 City Council Allocations Agreement between the City of San Diego and (1) Space 4 Art, Inc. in an amount not to exceed \$2,200, (2) YMCA of San Diego County in an amount not to exceed \$5,000, (3) San Diego Therapeutic Horsemanship in an amount not to exceed \$3,000, and (4) San Diego Opera Association in an amount not to exceed \$3,000, under the terms and conditions set forth in the Agreements on file in the Office of the City Clerk as Document No. RR-314893.1 for Space 4 Art, Inc., Document No. RR-314893.2 for San Diego County, Document No. RR-314893.4 for San Diego County, Document No. RR-314893.4 for San Diego County Association.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$13,200 from Council District 8: Community Projects, Programs, and Services budget Fund No. 100000, G/L Account No. 512059, Cost Center 1108110008, all to provide funds for the above-referenced Agreements, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
