A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING FUNDS FOR ARTS, CULTURE, AND COMMUNITY FESTIVALS TO SAN DIEGO AMERICAN INDIAN HEALTH CENTER, AND TEENAGE YOUTH PERFORMING ARTS THEATRE COMPANY, PURSUANT TO COUNCIL POLICY 100-23, "CITY COUNCIL FUNDING OF ARTS, CULTURE AND COMMUNITY FESTIVALS WITH DISCRETIONARY TRANSIENT OCCUPANCY TAX ALLOCATION."

WHEREAS, the Council of the City of San Diego (City Council) adopted Council Policy 100-23, titled "City Council Funding of Arts, Culture and Community Festivals with Discretionary Transient Occupancy Tax Allocation" on August 13, 2012, by San Diego Resolution R-307625 (August 13, 2012); and

WHEREAS, Council Policy 100-23 provides a procedure and uniform requirements for awarding funds to and contracting with private non-profit organizations that produce programs, projects, and events that (i) provide access to excellence in culture and the arts for residents of, and visitors to, the City of San Diego (City), and (ii) enrich the lives of the people of the City and build healthy, vital neighborhoods; and

WHEREAS, the City received and evaluated two applications for Arts, Culture, and Community Festivals (ACCF) funding for the following purposes:

San Diego American Indian Health Center	The Balboa Park Pow Wow	Promotes community pride and wellness by sharing diverse native cultural traditions with the community.
Teenage Youth Performing Arts Theatre Company	To Be Seen, To Be Heard, Expressions of Joy and Unity	Provides a space for conversations about identity and promotes community pride.

WHEREAS, it is the determination of the City Council that the above-described programs are consistent with Council Policy 100-23; and

WHEREAS, Council District 3 recommends an allocation of \$2,000 to San Diego

American Indian Health Center for performing artists, permit and event fees, insurance, janitorial services, and sanitary services, as set forth in this resolution; and

WHEREAS, Council District 3 recommends an allocation of \$1,500 to Teenage Youth
Performing Arts Theatre Company for performance artists and program support staff, marketing,
licensing requirements, and venue space, as set forth in this resolution; and

WHEREAS, the Office of the City Attorney has drafted this resolution based on the information provided by City staff, including information provided by affected third parties and verified by City staff, with the understanding that this information is complete, true, and accurate; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocation described in this resolution is made for a public purpose.

BE IT FURTHER RESOLVED, that the Mayor, or designee, is authorized and directed to execute, for and on behalf of the City, Arts, Culture, and Community Festivals Fiscal Year 2023 City Council Allocations Grant Agreements (Agreements) between the City of San Diego and (1) San Diego American Indian Health Center in an amount not to exceed \$2,000, and (2) Teenage Youth Performing Arts Theatre Company in an amount not to exceed \$1,500, under the terms and conditions set forth in the Agreements on file in the Office of the City Clerk as Document No. RR- 314899 1 for San Diego American Indian Health Center, and Document No. RR- 314899 2 for Teenage Youth Performing Arts Theatre Company.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$3,500 from Council District 3: TOT Fund No. 200205, G/L Account No. 512059, Cost Center 1414111214, to provide funds for the above-referenced Agreements, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
