A RESOLUTION OF THE COUNCIL OF THE CITY OF  
SAN DIEGO ALLOCATING FUNDS FOR ARTS, CULTURE,  
AND COMMUNITY FESTIVALS TO SAN DIEGO PARKS  
FOUNDATION FOR LOVE YOUR PARK DAY, PURSUANT  
TO COUNCIL POLICY 100-23, "CITY COUNCIL FUNDING  
OF ARTS, CULTURE AND COMMUNITY FESTIVALS WITH  
DISCRETIONARY TRANSIENT OCCUPANCY TAX  
ALLOCATION."

WHEREAS, the Council of the City of San Diego (City Council) adopted Council  
Policy 100-23, titled "City Council Funding of Arts, Culture and Community Festivals with  
Discretionary Transient Occupancy Tax Allocation" on August 13, 2012, by San Diego  
Resolution R-307625 (August 13, 2012); and

WHEREAS, Council Policy 100-23 provides a procedure and uniform requirements for  
awarding funds to and contracting with private non-profit organizations that produce programs,  
projects, and events that (i) provide access to excellence in culture and the arts for residents of,  
and visitors to, the City of San Diego (City), and (ii) enrich the lives of the people of the City and  
build healthy, vital neighborhoods; and

WHEREAS, San Diego Parks Foundation has requested funding for Love Your Park  
Day; and

WHEREAS, the requested funding will be used for art materials, cultural activities, dance  
instruction, entertainment costs, administrative fees, permit fees, event logistics, supplies, and  
marketing expenses; and

WHEREAS, San Diego Parks Foundation's request for funding for Love Your Park Day  
will benefit the public by providing San Diego families access to outdoor activities, which  
provides the community a healthy, enriching, and fun experience; and

WHEREAS, it is the determination of the City Council that the above-described program is consistent with Council Policy 100-23; and

WHEREAS, Council Districts 7, 8, and 9 recommend a total allocation of \$20,500 to the San Diego Parks Foundation for the purposes set forth in this resolution, attributed as follows: Council District 7 – \$8,000; Council District 8 – \$5,000; and Council District 9 – \$7,500; and

WHEREAS, the Office of the City Attorney has drafted this resolution based on the information provided by City staff, including information provided by affected third parties and verified by City staff, with the understanding that this information is complete, true, and accurate; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocations described in this resolution are made for a public purpose.

BE IT FURTHER RESOLVED, that the Mayor, or designee, is authorized and directed to execute, for and on behalf of the City, the Arts, Culture, and Community Festivals Fiscal Year 2023 City Council Allocations Grant Agreement between the City of San Diego and San Diego Parks Foundation (Agreement) in an amount not to exceed \$20,500, under the terms and conditions set forth in the Agreement on file in the Office of the City Clerk as Document No.



BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$8,000 from Council District 7: TOT Fund No. 200205, G/L Account No. 512059, Cost Center 1414111218; \$5,000 from Council District 8: TOT Fund No. 200205, G/L Account No. 512059, Cost Center 1414111219; and \$7,500 from Council District 9: TOT Fund No. 200205, G/L Account No. 512059, Cost Center 1414111220, for a total of \$20,500, all to provide funds for the above-referenced Agreement, contingent upon the Chief Financial

Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.


