A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO AUTHORIZING A FIRST AMENDMENT TO
AGREEMENT BETWEEN THE CITY OF SAN DIEGO AND
HDR ENGINEERING, INC. FOR POINT LOMA
WASTEWATER TREATMENT PLANT COASTAL EROSION
MONITORING PROGRAM IMPLEMENTATION (H2225956)
AND RELATED ACTIONS.

WHEREAS, on December 1, 2021, the City of San Diego (City) entered into a contract with HDR Engineering, Inc. (HDR) for Point Loma Wastewater Treatment Plant Coastal Erosion Monitoring Program Implementation (H2225956) (Agreement), to procure and install monitoring equipment along the Point Loma Coastal zone, and implement monitoring and data collection to ascertain the rate, scale, and threat of the erosion occurring on and around Gatchell Road near the entrance of the City's Point Loma Wastewater Treatment Plant (PLWTP); and

WHEREAS, the Agreement was effective October 15, 2021 through December 1, 2022;
and

WHEREAS, based on the data that was collected by HDR, it was determined that additional monitoring and data is necessary to identify the best option for repair; and

WHEREAS, City staff negotiated an amendment to the Agreement (First Amendment), which adds sixteen months and \$1,502,467 in order to continue coastal erosion monitoring and data collection; and

WHEREAS, if approved, the First Amendment will be retroactively effective as of December 2, 2022, and will increase the total Agreement not to exceed amount to \$3,263,672;
and

WHEREAS, the Office of the City Attorney has drafted this resolution based on the information provided by City staff, with the understanding that this information is complete, true, and accurate; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:


Section 1. The First Amendment to the Agreement, which adds 16 months for a total duration of 30 months and an increase of \$1,502,467 for a total not to exceed amount of \$3,263,672, under the terms and conditions more fully set forth in the First Amendment, which once signed by the Parties and approved by the City Attorney will be on file with the Clerk of the City of San Diego as Document No. RR-314920, is approved.

Section 2. The Mayor, or designee, is authorized to sign and deliver the First Amendment.

Section 3. The Chief Financial Officer is authorized to expend an amount not to exceed \$3,263,672, from Fund 700001, Metro Sewer Utility Fund, of which \$1,761,205 is already encumbered in PO 4200002747, for the purpose of fulfilling the City's obligations under the Agreement, contingent upon the Chief Financial Officer furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
