A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING A CONSTRUCTION CONTRACT WITH J.R. FILANC CONSTRUCTION COMPANY, INC. FOR THE PURE WATER PROGRAM CENTRAL AREA SMALL-SCALE FACILITY IN AN AMOUNT NOT TO EXCEED \$44,200,000 AND RELATED ACTIONS.

WHEREAS, Pure Water Phase 2 will deliver 53 million gallons per day (mgd) of purified water to either Murray Reservoir or San Vicente Reservoir; and

WHEREAS, the Pure Water Phase 2 Central Area Small-Scale Facility will run wastewater through two parallel treatment trains modeling the Murray and San Vicente treatment options and will consist of water reclamation plant processes and advanced water purification process trains to demonstrate compliance with recycled water objectives, and determine parameters for full-scale design of the Pure Water Phase 2 facilities (Project); and

WHEREAS, on November 1, 2021 City Council adopted Resolution Number R-313764, approving Capital Improvement Program Budget for Pure Water Phase 1 and Pure Water Phase 2 and authorizing execution of construction contracts to the lowest responsible and reliable bidders for Pure Water Phase 2; and

WHEREAS, the City opened the bids Project on January 12, 2023 and J.R. Filanc Construction Company, Inc. was the lowest responsible bidder; however, the bid amount plus the 15% contingency exceed the \$40,000,000 that was authorized by Council for the Project; and

WHEREAS, in order to ensure that sufficient funds area available for the Project, it is necessary to transfer \$10,200,000 previously appropriated to other CIP funds to the Pure Water Program Phase 2 fund; and

WHEREAS, the Office of the City Attorney has drafted this resolution based on the information provided by City staff, with the understanding that this information is complete, true, and accurate; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, as follows:

- 1. The construction contract with J.R. Filanc Construction Company, Inc. for the Pure Water Program Central Area Small-Scale Facility (K-23-2119-DBB-3-C) in amount not to exceed \$44,200,000 that, once signed by all parties and approved by the City Attorney, will be on file with the City Clerk as Document No. 21-314923 , is approved.
 - 2. The Mayor is authorized to sign and deliver the construction contract.
- 3. The Chief Financial Officer is authorized to transfer \$6,324,000 from CIP A-KB.00003, Water Main Replacements, Fund 700010, Water Utility CIP and \$3,876,000 from CIP A-LA.00001, Pure Water Program, Fund 700009, Metro Sewer CIP, to CIP A-LA.00002, Pure Water Program Phase 2.
- 4. The Chief Financial Officer is authorized to expend funds in an amount not to exceed \$44,200,000 from CIP A-LA.00002, Pure Water Program Phase 2, PWP Central Area Small-Scale Facility (B-21151), of which \$16,796,000 is from Fund 700009, Metro Sewer CIP, and \$27,404,000 from Fund 700010, Water Utility CIP, contingent upon the Chief Financial Officer furnishing one or more certificates certifying that funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
