DATE OF FINAL PASSAGE MAY 26 2023

A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO CONFIRMING AN APPOINTMENT AND
REAPPOINTMENT TO THE SAN DIEGO HOUSING
COMMISSION.

WHEREAS, the San Diego Housing Commission (Commission) is established in
San Diego Municipal Code (Municipal Code) section 98.0301 to act as a Housing Commission
under the Housing Authorities Law of the State of California; and

WHEREAS, Municipal Code section 98.0301(f) provides that the Commission shall
consist of seven members appointed by the Mayor and confirmed by the Council of the City of
San Diego (City Council); and

WHEREAS, Municipal Code section 98.0301(f)(1) also provides that, of the seven
members appointed by the Mayor, two members shall be tenants of Commission-owned units or
recipients of housing assistance pursuant to the United States Department of Housing and Urban
Development's tenant-based housing choice voucher program (Tenant Housing Authority
Commissioners), and at least one of the Tenant Commissioners shall be older than 62; and

WHEREAS, Municipal Code section 98.0301(f)(2) also provides that each member,
except the two Tenant Housing Authority Commissioners, shall have at least five years of
experience in one or more of the following areas: real estate finance, affordable housing,
homelessness, workforce development, healthcare, nonprofit education, or community based-
organizations; and

WHEREAS, the term of office of each member shall be four years, except that the terms
two Tenant Housing Authority Commissioners shall be two years, as set forth in section 34272
of the Health and Safety Code of the State of California; and

WHEREAS, the Mayor now seeks City Council confirmation of one appointment and one reappointment to the Commission; and

WHEREAS, the Office of the City Attorney has drafted this resolution based on the information provided by City staff, including information provided by affected third parties and verified by City staff, with the understanding that this information is complete, true, and accurate; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the following appointment and reappointment by the Mayor of the City of San Diego, to serve as members of the San Diego Housing Commission, for terms expiring as indicated, are made and hereby confirmed:
