A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING AN AGREEMENT WITH CHEN RYAN ASSOCIATES, INC. FOR AS-NEEDED ENGINEERING SUPPORT CONSULTANT SERVICES AND RELATED ACTIONS.

WHEREAS, the City's Transportation Department seeks to consolidate as-needed consultants that provide engineering support services to the department into two comprehensive agreements; and

WHEREAS, the scope of engineering support services will include, but not be limited to, vehicular and traffic improvements studies, traffic control plans, design services, construction support services, soil investigation, urban forestry services, undergrounding utility services, code compliance services, asset management studies and reports, and remote sensing techniques; and

WHEREAS, on October 25, 2022, Transportation issued a Request for Proposals (RFP) to retain the services of two qualified consultants for comprehensive engineering support services on an as-needed basis; and

WHEREAS, based on selection rating criteria and procedures, the Transportation

Department selected Chen Ryan Associates, Inc. for best value as one of the two most qualified consultants following a competitive selection process; and

WHEREAS, the proposed agreement with Chen Ryan Associates, Inc. will have a minimum aggregate value of \$1,000 and a total not-to-exceed amount of \$7,500,000, for a duration of five years; and

WHEREAS, the Office of the City Attorney has drafted this resolution based on the information provided by City staff, with the understanding that this information is complete, true, and accurate; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. The Agreement with Chen Ryan Associates, Inc. (H2226054), to provide asneeded engineering support consultant services for a minimum of \$1,000 and a total amount not to exceed \$7,5000,000 for the duration of five years under the terms and conditions set forth in the Agreements on file in the Office of the City Clerk as Document No. RR. 314939 is approved.

- 2. The Mayor is authorized to sign and deliver the Agreement.
- 3. The Chief Financial Officer is authorized to expend funds in an amount not to exceed \$7,500,000, with a minimum guarantee from Fund 200217 (Undergrounding Surcharge Fund) requiring these services for the purposes of funding the Agreement, contingent upon the adoption of the Annual Appropriation Ordinance for the applicable fiscal year and contingent upon the Chief Financial Officer first certifying funds are, or will be, on deposit with the City Treasurer.
