A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO APPROVING A SIDE LETTER AGREEMENT
BETWEEN THE CITY AND THE SAN DIEGO POLICE
OFFICERS ASSOCIATION, TO AMEND ARTICLE 49 OF THE
MEMORANDUM OF UNDERSTANDING RELATED TO FREE
MTS TRANSIT PASSES.

WHEREAS, by San Diego Resolution R-314185 (June 23, 2022), the San Diego City Council (Council) approved a Memorandum of Understanding (MOU) between the City of San Diego (City) and the San Diego Police Officers Association (POA) regarding terms and conditions of employment for employees represented by POA for fiscal years 2023 and 2024; and

WHEREAS, the City's Climate Action Plan provides that vehicles are the single largest source of greenhouse gas (GHG) emissions in San Diego and more than two-thirds of smog-forming emissions in San Diego County are generated from mobile sources; and

WHEREAS, in an effort to further the Climate Action Plan's goal to shift away from a car-centric transportation system, support a loading priority for our roadways, and reduce GHG emissions, the City will offer its employees a free Universal Pass (U-Pass) through the San Diego Metropolitan Transit System (MTS); and

WHEREAS, the U-Pass includes all MTS fixed-route services, including the Regional Rapid Express commuter services. The U-Pass is part of the City's Transportation Alternatives Program, which incentivizes and encourages employees to utilize mass transit and van pools as their primary mode of transportation to and from work; and


WHEREAS, the City and POA entered into a side letter agreement (Agreement) to amend Article 49 of the MOU related to free MTS transit passes; and

WHEREAS, the Agreement must be approved by a two-thirds majority vote of the Council to take effect, in accordance with Charter section 11.2; and

WHEREAS, the Office of the City Attorney has drafted this resolution based on the information provided by City staff, including information provided by affected third parties and verified by City staff, with the understanding that this information is complete, true, and accurate; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Agreement between the City and POA to amend Article 49 of the MOU related to free MTS transit passes, presented to the Council and on file in the Office of the City Clerk as Document No. RR-**314948** _____, is approved, and takes effect upon the date of final passage of this Resolution.
