A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO INCREASING THE NOT TO EXCEED CONTRACT AMOUNTS AT WHICH THE MAYOR MAY EXECUTE CONTRACTS FOR SLURRY SEAL GROUPS 2324, 2325 AND 2326, AND RELATED ACTIONS

WHEREAS, on June 30, 2022, the Council of the City of San Diego (Council) adopted San Diego Resolution R-314144, which authorized the Mayor to award contracts for Slurry Seal Groups 2324, 2325, and 2326 provided that the amount of the contracts did not exceed \$5,500,000.00 for Slurry Seal Group 2324, \$5,082,021.50 for Slurry Seal Group 2325, and \$5,082,021.50 for Slurry Seal Group 2326; and

WHEREAS, City staff has determined that the contracts for each Slurry Seal Group will exceed the previously authorized amounts because additional striping changes are necessary to implement new or improved bike lanes; and

WHEREAS, this action if approved, will authorize the use of \$2,498,650.00 in TransNet funding for Slurry Seal Group 2324, 2325, and 2326 projects, and will authorize the Mayor to execute contracts for those projects at increased not to exceed amounts; and,

WHEREAS, the Office of the City Attorney has drafted this resolution based on the information provided by City staff, including information provided by affected third parties and verified by City staff, with the understanding that this information is complete, true, and accurate; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, as follows:

1. That the Mayor, or designee, is authorized to execute contracts with the lowest responsible and reliable bidder, in an amount not to exceed \$6,404,750.00 for Slurry Seal Group 2324, \$5,727,721.50 for Slurry Seal Group 2325, and \$6,030,221.50 for Slurry Seal Group 2326, contingent upon the Chief Financial Officer furnishing a certificate that funds necessary for the expenditure are, or will be, on deposit with the City Treasurer.

2. That the Chief Financial Officer is authorized to appropriate and expend an additional \$904,750.00 for a total contract cost not to exceed \$6,404,750.00 for Slurry Seal Group 2324 from Fund 400170 TransNet Fund contingent upon the Chief Financial Officer furnishing a certificate certifying that funds necessary for the construction contract expenditures are, or will be, on deposit with the City Treasurer.

3. That the Chief Financial Officer is authorized to appropriate and expend an additional \$645,700.00 for a total contract cost not to exceed \$5,727,721.50 for Slurry Seal Group 2325 from Fund 400170 TransNet Fund contingent upon the Chief Financial Officer furnishing a certificate certifying that funds necessary for the construction contract expenditures are, or will be, on deposit with the City Treasurer.

4. That the Chief Financial Officer is authorized to appropriate and expend an additional \$948,200.00 for a total contract cost not to exceed \$6,030,221.50 for Slurry Seal Group 2326 from Fund 400170 TransNet Fund contingent upon the Chief Financial Officer furnishing a certificate certifying that funds necessary for the construction contract expenditures are, or will be, on deposit with the City Treasurer.
