A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE MAYOR TO ACCEPT THE DONATION OF 43 ACRES OF UNDEVELOPED REAL PROPERTY IN THE EAST ELLIOTT AREA OF SAN DIEGO FROM TRI POINTE HOMES IE-SD, INC.

WHEREAS, Tri Pointe Homes IE-SD, Inc. (Tri Pointe Homes) has offered to donate to the City of San Diego (City) 43 acres of undeveloped real property in the East Elliott area of San Diego, identified as Assessor's Parcel Numbers 366-081-03 and 366-081-50 (Property); and

WHEREAS, the Property is within the City's Multi-Habitat Planning Area and consists of undisturbed native habitat, including a mixture of Diegan Coastal Sage Scrub and valley and foothill grasslands; and

WHEREAS, the City wishes to accept the donation of the Property to become part of Mission Trails Regional Park and to increase the City's open space in the East Elliott area; and

WHEREAS, the appraised value of the Property is \$1,532,000; and

WHEREAS, the Department of Real Estate and Airport Management conducted due diligence, including a Phase I Environmental Site Assessment, and determined that no potential liabilities associated with the Property exist; and

WHEREAS, the Parks and Recreation Department determined that it can absorb the expenditure and maintenance obligations for the Property within Mission Trails Regional Park's existing operations budget; and

WHEREAS, the Parks and Recreation Department determined that existing Mission Trails Regional Park Ranger staff can assume the maintenance obligations for the Property; and

WHEREAS, the Department of Real Estate and Airport Management determined that the donation is in the City's best interest and acceptance is consistent with applicable City laws, policies, ordinances, and resolutions; and

WHEREAS, the City and Tri Pointe Homes negotiated the terms of a Grant Deed (Grant Deed), a copy of which is included in the docket materials accompanying this Resolution; and


WHEREAS, the Grant Deed requires that the City use and maintain the Property in perpetuity as open space and makes the Property part of the City's Multiple Species Conservation Program; and

WHEREAS, the Office of the City Attorney has drafted this Resolution based on the information provided by City staff (including information provided by affected third parties and verified by City staff), with the understanding that this information is complete, true, and accurate; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. The Mayor or designee is authorized, on the City's behalf, to accept the donation of the Property from Tri Pointe Homes.
2. The Mayor or designee is authorized, on the City's behalf, to sign and deliver the Grant Deed and all other documents necessary or appropriate to accept the donation of the Property from Tri Pointe Homes. The Grant Deed, when signed by both parties, shall be placed on file in the Office of the City Clerk as Document No. RR-315028.

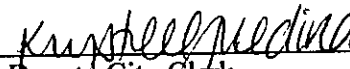
