A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO TO APPROVE THE REVISED SAN DIEGO HUMANE SOCIETY ANIMAL SERVICES USER FEE SCHEDULE.

WHEREAS, on April 24, 2023, the Council of the City of San Diego (Council) approved a 10-year agreement between the City of San Diego (City) and the San Diego Humane Society (SDHS), on file with the Office of the City Clerk as Document # 00-21648, to continue providing animal services to the City effective July 1, 2023, through June 30, 2033; and

WHEREAS, the approved 10-year agreement with SDHS did not include a revised list of user fees (fee schedule) as part of the contract; and

WHEREAS, the City agreed to submit a revised fee schedule to Council for their consideration; and

WHEREAS, on June 21, 2023, the Budget and Government Efficiency Committee directed staff to include detailed responses to factors identified in Section C of Council Policy 100-05, before the revised fee schedule item is brought to Council; and

WHEREAS, Section C of Council Policy 100-05 contains factors that should be considered during a comprehensive user fee study or a department-initiated change to user fees, including (1) Whether service costs are covered by revenues received; (2) Whether fees cover costs and generate excess revenue that supplement other services; (3) A comparison of fee levels for similar services provided in other jurisdictions (i.e., benchmarking); (4) An analysis of all relevant costs involved including direct and indirect costs; (5) The current volume and the projected volume and associated revenue based on the changes in the fees; (6) Subsidization costs as pertains to the difference between the revenue from and the cost of providing the

service; and (7) Identification of any user fees that have not been revised/updated in the last five years or longer and documentation from the affected department substantiating any proposed user fee revisions or alternatively, the justification for maintaining current fee levels; and

WHEREAS, an analysis of the factors contained in Council Policy 100-05, as set forth above, indicates that the revised fee schedule does not fully recover the price for the services provided to the City; however, the purpose of the City's animal services fee structure is not to generate revenue. Instead, the fees are set to a lower and more affordable level in order to promote and encourage animal adoptions, prevent cruelty and neglect to animals, and provide medical care to animals in need, all of which help protect the health and safety of the public and animals in the City. In addition, some animal services fees are set to a lower and more affordable level as a means of securing compliance with laws and regulations (for example, fees for dog licensing and impounding stray animals); and

WHEREAS, the revised fee schedule will also align with the fee structure of all 12 municipalities with whom SDHS contracts and with a "benchmark" per Section D of Council Policy 100-05 with the 66 other municipal, non-profit, and for-profit animal service welfare organizations throughout California; and

WHEREAS, the Office of the City Attorney has drafted this resolution based on the information provided by City staff, including information provided by affected third parties and verified by City staff, with the understanding that this information is complete, true, and accurate; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the revised SDHS User Fee Schedule is approved.

BE IT FURTHER RESOLVED that the revised SDHS User Fee Schedule will become effective on August 15, 2023.
