A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING AND RATIFYING A SIDE LETTER AGREEMENT BETWEEN THE CITY OF SAN DIEGO AND CALIFORNIA TEAMSTERS LOCAL 911 RELATED TO PAYMENT OF INTEREST TO THE SAN DIEGO CITY EMPLOYEES' RETIREMENT SYSTEM.

WHEREAS, on April 13, 2016, the San Diego City Council (Council) adopted San Diego Ordinance O-20636 approving a Side Letter Agreement between the City of San Diego (City) and the San Diego Municipal Employees Association related to the payment of interest to the San Diego City Employee's Retirement System (SDCERS or Retirement System); and

WHEREAS, the terms of the Side Letter Agreement provide the City will indemnify eligible employees for interest charges associated with the underpayment of contributions and overpayment of benefits resulting from errors by SDCERS or the City; and

WHEREAS, during Fiscal Year successor MOU negotiations, the City reached tentative agreements with Local 127, American Federation of State, County, and Municipal Employees, AFL-CIO (Local 127) and the Deputy City Attorneys Association of San Diego (DCAA) to amend Articles 69 and 46 of their MOUs, respectively, to indemnify eligible employees for interest charges associated with the underpayment of contributions and overpayment of benefits resulting from an error by SDCERS or the City; and

WHEREAS, the Local 127 and DCAA tentative agreements were approved by Council approval at its June 6, 2023 meeting; and

WHEREAS, the City Council now desires to approve the Side Letter Agreement between the City and California Teamsters Local 911 (Local 911) related to payment of interest to SDCERS associated with underpayment of contributions or overpayment of benefits resulting

from errors by SDCERS or the City, and to retroactively apply these terms to Local 911 effective as of July 1, 2023; and

WHEREAS, the Council, in approving this Side Letter Agreement, finds that it is in the best interests of the City to indemnify Local 911-represented employees for interest payments related to errors by SDCERS or the City, when these employees, detrimentally impacted by the errors of SDCERS or the City, are not at fault; and

WHEREAS, the Side Letter Agreement has been negotiated pursuant to the MMBA and City Council Policy 300-06 and is subject to City Council approval to take effect; and

WHEREAS, the negotiated Side Letter Agreement must be approved by a two-thirds majority vote of this Council in accordance with San Diego Charter section 11.2; and

WHEREAS, the Office of the City Attorney has drafted this resolution based on the information provided by City staff, including information provided by affected third parties and verified by City staff, with the understanding that this information is complete, true, and accurate; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that, pursuant to the authority of the MMBA and Council Policy 300-06, the Council approves the Side Letter Agreement between the City and Local 911, which is on file in the Office of the City Clerk as Document No. RR
315036, retroactive to July 1, 2023.
