A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE FIRST AMENDMENT TO THE LEGAL SERVICES AGREEMENT WITH BUCHALTER APC AS OUTSIDE COUNSEL TO PROVIDE CONTINUING LEGAL SERVICES RELATED TO INSURANCE COVERAGE RECOVERY ON THE DE ANZA MATTER AND INDEMNIFICATION ON THE 101 ASH MATTER.

WHEREAS, the City of San Diego (City) has been involved in several litigation matters relating to De Anza Cove (De Anza Matter) and has retained the services of attorney

Cecilia Miller as outside counsel since 2009 to obtain recovery from the City's insurance carriers to cover a portion of the settlement amounts that the City is obligated to pay in those matters;

WHEREAS, the City has also retained the services of attorney Cecilia Miller as outside counsel since February 2020 to assist the City in identifying potential sources of indemnification on behalf of the City for the purchase and renovation of the building at 101 West Ash Street (101 Ash Matter);

WHEREAS, on June 25, 2021, by San Diego Resolution R-2021-412 (June 25, 2021), the Council approved the retention of the Buchalter Law Firm (Law Firm), where Ms. Miller is a Shareholder, to pursue indemnification and recovery of insurance proceeds against the City's insurance carriers in the De Anza Matter and to identify potential sources of indemnification in the 101 Ash Matter. The contract with the Law Firm was approved, with a not-to-exceed amount of \$600,000 pursuant to the Purchasing and Contracting Director's execution of a sole source

certification memo to proceed with retention of the Law Firm because the City receives no competitive advantage by conducting a more formal competitive solicitation;

WHEREAS, the City Attorney's Office (Office) is now seeking an increase only to the not-to-exceed amount of the Contract and does not seek any other amendment to the Contract;

WHEREAS, the proposed First Amendment to increase the Contract by an additional \$800,000 is necessary to allow the Law Firm to represent the City in litigation against the City's insurers in the De Anza Matter and to continue to pursue indemnification for the City in the 101 Ash Matter, because the City Attorney's Office lacks the expertise as relates to the unique insurance and indemnification recovery issues of these two matters;

WHEREAS, this Office seeks Council approval of the First Amendment to the Contract; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Council approves and authorizes the Mayor or his designee to execute the First Amendment to the Contract with the Law Firm, to increase the total not to exceed amount to \$1,400,000 from \$600,000, for a total of \$800,000 for the First Amendment.

BE IT FURTHER RESOLVED, that the Council authorizes the appropriation and expenditure of an amount not to exceed \$800,000 (with a total not to exceed amount of \$1,400,000 for the contract) from the Public Liability Fund No. 720045 for purposes of funding the First Amendment to the Contract, with this authorization contingent upon the adoption of the

Annual Appropriation Ordinance for the applicable fiscal year in which the funds will be expended and the Chief Financial Officer furnishing one or more certificates certifying that funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
