A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO DETERMINING THAT THE AWARD AND EXECUTION OF AMENDMENT NO. 1 TO CONTRACT H207152 WITH BLUE LAKE CIVIL FOR PROFESSIONAL ENGINEERING SERVICES FOR AC WATER AND SEWER GROUP JOB 1033 IS STATUTORILY EXEMPT FROM CEQA PURSUANT TO STATE CEQA GUIDELINES SECTION 15262.

WHEREAS, in March 2020, the City prepared and advertised a Request for Proposal for selection of a consultant to provide professional engineering services for AC Water And Sewer Group Job 1033; and

WHEREAS, through the competitive selection process, Blue Lake Civil (Consultant) was identified as the most highly qualified consultant; and

WHEREAS, on August 3, 2021, the San Diego City Council (Council) passed Ordinance No. O-21363 authorizing the Mayor, or his designee, to execute a consultant agreement with Consultant to provide professional engineering services to prepare plans, specifications, and cost estimates for completion of AC Water and Sewer Group Job 1033; and

WHEREAS, the City and Consultant entered into Contract H207152 to provide professional engineering services for AC Water and Sewer Group Job 1033 (Agreement); and

WHEREAS, during the design phase of the Project, additional necessary design requirements for AC Water and Sewer Group Job 1033 were identified; and

WHEREAS, an amendment to the Agreement is now necessary in order to cover the additional design requirements (Amendment No. 1); and

WHEREAS, within the California Environmental Quality Act (CEQA) (Public Resources Code section 21000, et seq.), Public Resources Code section 21084 states that the CEQA Guidelines (California Code of Regulations, Title 14, Chapter 3, Section 15000, et seq.) adopted by the California Office of Planning and Research under Public Resources Code section 21083 shall list those classes of projects which have been determined not to have a significant effect on the environment and which shall be exempt from CEQA; and

WHEREAS, California Public Resources Code section 21084, which is a part of CEQA, states that the CEQA Guidelines shall list those classes of projects which have been determined not to have a significant effect on the environment and which shall be exempt from CEQA; and

WHEREAS, pursuant to that authority, CEQA Guidelines sections 15260 through 15285 list the statutory CEQA exemptions promulgated by the California State Legislature; and

WHEREAS, City staff has established that the Amendment No. 1 to the Agreement for professional design and engineering services (Project) is statutorily exempt from CEQA pursuant to CEOA Guidelines section 15262 entitled "Feasibility and Planning Studies"; and

WHEREAS, the Council has considered the potential environmental effects of the Project; and

WHEREAS, the Council, using its independent judgment, has determined that the Project will not have a significant effect on the environment because it meets the requirement of CEQA Guidelines section 15262, in that it is a project involving only a feasibility or planning study for possible future actions; and

WHEREAS, the Council has held a public hearing, and has reviewed and considered the written and verbal testimony and evidence presented at or before the public hearing, regarding the subject matter of this Resolution; and

WHEREAS, the Office of the City Attorney has drafted this resolution based on the information provided by City staff with the understanding that this information is complete, true, and accurate; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Project will not result in a significant effect on the environment and is statutorily exempt from CEQA under CEQA Guidelines section 15262.
