City of San Diego, et al.*, San Diego Superior Court Case No. 37-2016-00027281-CU-PA-CTL (Litigation), allegedly due to the allowance of parking on the westside of the road; and

WHEREAS, in Closed Session on June 12, 2023, the City Council, by the following votes: Yeas, Districts 1, 2, 3, 4, 6, 7, 8 and 9; Nays: District 5; and Absent, none; approved the settlement for an amount consistent with the amount set forth below; and

BE IT RESOLVED, by the City Council of the City of San Diego, that the Council:

1. Authorizes the Mayor or his designee to pay the sum of \$4,800,000.00 from Public Liability Fund No. 720045 in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorney fees, against City of San Diego, its agents and employees, arising from the *Joseph Lopez et al. v. City of San Diego, et al.* matter.
