A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO APPROVING THE CONTRACT BETWEEN THE
CITY OF SAN DIEGO AND ORION CONSTRUCTION
CORPORATION FOR THE EL CAPITAN DAM SPILLWAY
NEAR TERM REPAIR PROJECT (BID NO. K-23-2126-DBB-3)
AND RELATED ACTIONS.

WHEREAS, El Capitan Dam is a 237-foot high embankment dam constructed from 1932 to 1934 across the San Diego River approximately seven miles east of Lakeside, California; and

WHEREAS, the dam and reservoir are owned and operated by the City of San Diego for water supply purposes; and

WHEREAS, El Capitan Dam is under the jurisdiction of California Department of Water Resources, Division of Safety of Dams (DSOD), and has a downstream hazard classification of “extremely high;” and

WHEREAS, City completed a comprehensive condition assessment of the spillway at El Capitan Dam on January 21, 2019, in accordance with DSOD requirements, which identified certain deficiencies that need to be addressed; and

WHEREAS, after DSOD reviewed and accepted the recommendations in the comprehensive condition assessment report, the City developed a near term maintenance repair plan to address the spillway deficiencies and to reduce impacts on spillway safety and performance; and

WHEREAS, the El Capitan Dam Spillway Near-Term Repair project was advertised on March 14, 2023, with bid number K-23-2126-DBB-3, and Orion Construction was identified as the apparent low bidder with a base bid of \$4,872,000; and

WHEREAS, the Office of the City Attorney has drafted this resolution based on the information provided by City staff, including information provided by affected third parties and verified by City staff, with the understanding that this information is complete, true, and accurate; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, as follows:


1. The contract for construction services (K-23-2126-DBB-3) with Orion Construction Corporation in an amount not to exceed \$4,872,000 for the purpose of completing the El Capitan Dam Spillway Near-Term Repair project (Contract), which once signed will be on file with the City Clerk as Document No. RR-315104, is approved.

2. The Mayor or designee is authorized to sign and deliver the Contract.

3. The Chief Financial Officer is authorized to appropriate and expend an amount not to exceed \$4,872,000 from fund 700011, Water Utility Operating Fund, for the purposes of fulfilling the Contract, contingent upon the Chief Financial Officer furnishing a certificate certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
