A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO AUTHORIZING AWARD OF AGREEMENT
WITH SWT ENGINEERING, INC. FOR AS-NEEDED
LANDFILL ENGINEERING AND ENVIRONMENTAL
CONSULTING SERVICES, H2226092

WHEREAS, in accordance with A.R. 25.60 (Selection of Consultants for Work Requiring Licensed Architect and Engineering Skills) and Council Policy 300-07 (Consultant Services Selection), the Environmental Services Department (ESD) advertised a Request for Proposals (RFP) for As-Needed Landfill Engineering and Environmental Consulting Services on September 2, 2022 and received responsive proposals from four (4) consulting firms; and

WHEREAS, a selection panel determined that SWT Engineering, Inc. (SWT) is the most qualified firm per the technical requirements and evaluation criteria established in the RFP; and

WHEREAS, the work to be performed by SWT under this five-year as-needed agreement includes storm water regulation compliance support, analysis, planning, evaluation, design, and Engineer of Record services associated with facilities owned or operated by ESD including but not limited to the West Miramar Landfill, Miramar Greenery, other City-owned closed/inactive landfills, and burn ash disposal sites throughout the City; and

WHEREAS, SWT has strong technical expertise in the field of landfill engineering and has substantial prior working experience within the San Diego region; and

WHEREAS, the Office of the City Attorney has drafted this resolution based on the information provided by City staff [including information provided by affected third parties and verified by City staff], with the understanding that this information is complete, true, and accurate; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the Mayor, or his designee, is authorized to execute an agreement with SWT Engineering, Inc. to provide As-Needed Landfill Engineering and Environmental Consulting Services in an amount not to exceed \$7,500,000.00, under the terms and conditions set forth in the Agreement on file in the Office of the City Clerk as Document No. RP-315105.

2. That the Chief Financial Officer is authorized to expend an amount not to exceed \$7,500,000.00 over five (5) years for the purpose of funding the As-Needed Landfill Engineering and Environmental Consulting Services agreement with SWT Engineering, Inc., contingent upon adoption of the annual Appropriations Ordinance for the applicable fiscal year, and contingent upon the Chief Financial Officer furnishing one or more certificates certifying that funds necessary for expenditure are, or will be, on deposit with the City Treasurer.

3. That the Chief Financial Officer is authorized to expend an amount not to exceed \$1,000.00 from CIP A-FA.00001, Landfill Improvements, Fund 700040, Refuse Disposal Fund, for the purpose of executing this Agreement and meeting minimum contract requirements.
