RESOLUTION OF THE COUNCIL OF THE CITY OF  
SAN DIEGO ADOPTING THE 2023 UPDATE TO THE SAN  
DIEGO COUNTY MULTI-JURISDICTION HAZARD  
MITIGATION PLAN.

WHEREAS, as a federal requirement under the Disaster Mitigation Act of 2000, to qualify for hazard mitigation program grants and post disaster mitigation funds, local governments are required to have an approved hazard mitigation plan adopted and in place; and

WHEREAS, the San Diego County Multi-Jurisdiction Hazard Mitigation Plan (Plan) serves this purpose by identifying the most significant natural hazards and other manmade threats posed to the region, and also specifies goals, objectives, and actions to mitigate the impacts from such hazards for eighteen participating jurisdictions; and

WHEREAS, the Federal Emergency Management Agency (FEMA) provisionally reviews and approves all Plans pursuant to federal law; and


WHEREAS, in 2004 the City first completed the regional Plan and approved updates in 2010, 2015, and 2018; and

WHEREAS, FEMA provisionally reviewed the 2023 Plan, with final approval pending adoption of resolutions from all eighteen participating jurisdictions; and

WHEREAS, the Office of the City Attorney has drafted this resolution based on the information provided by City staff, with the understanding that this information is complete, true, and accurate; NOW, THEREFORE,

BE IT RESOLVED, the City of San Diego hereby adopts the 2023 update to the Plan on file with the City Clerk as document number RR- 315106.
