A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO CONFIRMING APPOINTMENTS AND A REAPPOINTMENT TO THE MUNICIPAL GOLF COMMITTEE.

WHEREAS, the City of San Diego's (City) Municipal Golf Committee has been established to advise the Parks and Recreation Board, Mayor, and Council of the City of San Diego (Council) on policy issues relating to the acquisition, development, maintenance, and operation of the Balboa, Mission Bay, and Torrey Pines golf courses (the Municipal Golf Courses); and

WHEREAS, the Municipal Golf Committee is to consist of eleven members, who shall serve without compensation; and

WHEREAS, members are to be appointed by the Mayor and confirmed by the Council, and are to include the following: (1) one member with expertise in accounting or financial management; (2) one member representing a lessee from one of the Municipal Golf Courses; (3) one member with expertise in general business; (4) one member with expertise in golf course architecture, landscape architecture, or irrigation management; (5) one member from the Torrey Pines Golf Course Men's or Women's Club; (6) one member from the Balboa Park Golf Course Men's or Women's Club; (7) one member representing the Mission Bay Golf Course, until such time as a club is formed for this golf course, at which time the member shall be from that club; (8) one member who is a youth golf program professional; and (9) three members who will serve as at-large members, but who shall have experience playing golf, utilizing the golf courses, or who shall be familiar with the courses and needs of golfers in general; and WHEREAS, for initial appointments, five members shall be appointed to a term of two years, and six members shall be appointed to a term of four years, with subsequent appointments to be for four-year terms; and

WHEREAS, all terms shall expire on May 1 of a given year and members may serve a maximum of two terms; and

WHEREAS, the Office of the City Attorney has drafted this resolution based on the information provided by City staff, including information provided by affected third parties and verified by City staff, with the understanding that this information is complete, true, and accurate; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the following appointments and reappointment by the Mayor of the City of San Diego, to serve as members of the Municipal Golf Committee, for terms expiring as indicated, are made and hereby confirmed:
