A RESOLUTION OF THE COUNCIL OF THE CITY OF  
SAN DIEGO APPROVING THE SETTLEMENT AGREEMENT  
BETWEEN ELANTE SHINE AND CITY OF SAN DIEGO, ET  
AL.

WHEREAS, on July 20, 2020, Elante Shine filed a lawsuit in San Diego Superior Court, against Officer Dillon Fuston, et al., alleging personal injuries from an incident that occurred on December 14, 2019, in the Gaslamp Quarter of the City of San Diego. The lawsuit was titled *Elante Shine v. City of San Diego, et al.*, San Diego Superior Court, Case No. 37-2020-00025165-CU-CR-CTL; and

WHEREAS, on October 22, 2020, the City removed the lawsuit to United States District Court, Southern District of California. The District Court lawsuit is titled, *Elante Shine v. City of San Diego, et al.*, United States District Court, Case No. 20cv2036-LAB-DEB (Litigation); and

WHEREAS, in Closed Session on July 17, 2023, by the following votes: Yeas, Districts 1, 2, 3, 4, 6, 8, and 9; Nays, none; and Absent, 5 and 7; approved the Settlement of the Litigation for an amount consistent with the amounts set forth below; NOW, THEREFORE,


BE IT RESOLVED, by the City Council of the City of San Diego, that the Council:

1. Authorizes the Mayor or his designee to pay the sum of \$875,000.00 from Public Liability Fund No. 720045, in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorney fees, against the City of San Diego, its agents and employees, arising from the Litigation.

2. Authorizes the Chief Financial Officer to expend an amount not to exceed \$875,000.00 from Public Liability Fund No. 720045, for the purpose of settling the Litigation.
