A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE SETTLEMENT AGREEMENT BETWEEN ENRIQUE RIOS AND THE CITY OF SAN DIEGO, ET AL.

WHEREAS, on February 17, 2021, Enrique Rios (Plaintiff) filed suit against the City of San Diego alleging personal injury arising from the August 14, 2020, motor vehicle accident at an intersection where the traffic light malfunctioned. The lawsuit is titled *Enrique Rios v. City of San Diego*, et al., San Diego Superior Court Case No. 37-2021-00006880-CU-PA-CTL (Litigation); and

WHEREAS, on April 4, 2022, the City filed a Cross Complaint against Ryan Canedy and Veritiv Operating Company (Cross-Defendants). On May 25, 2023, Plaintiff filed an Amended Complaint against Cross-Defendants. On June 23, 2023, Cross-Defendants filed a Cross-Complaint against the City of San Diego; and

WHEREAS, in Closed Session on July 10, 2023, by the following votes: Yeas, Districts 1, 2, 4, 5, 6, 7, 8, and 9; Nays, none; and Absent, 3; approved the Settlement of the Litigation for an amount consistent with the amounts set forth below; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Council:

1. Authorizes the Mayor or his designee to pay the sum of \$250,000.00 from Public Liability Fund No. 720045, in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorney fees, against the City of San Diego, its agents and employees, arising from the Litigation.
