

RESOLUTION NUMBER R- 315127DATE OF FINAL PASSAGE SEP 20 2023A RESOLUTION OF THE COUNCIL OF THE CITY OF  
SAN DIEGO CONFIRMING AN APPOINTMENT TO THE  
CITIZENS EQUAL OPPORTUNITY COMMISSION.

WHEREAS, San Diego Municipal Code section 26.16 (Municipal Code) established the Citizens Equal Opportunity Commission (Commission); and

WHEREAS, the Municipal Code provides that the Commission monitor and evaluate the City of San Diego's (City) Equal Opportunity Program; advise the Mayor, Council of the City of San Diego (Council), Civil Service Commission, and other appropriate agencies of the City government; submit written annual reports that evaluate the progress of the City and its agencies to the Council's Committee on Budget and Government Efficiency and the Council for review; assist in recruiting competent minorities, women, and disabled persons to compete for available City positions; and promote the City as an Equal Opportunity Employer of individuals and firms desiring to contract with the City; and

WHEREAS, the Commission shall consist of 11 members appointed by the Mayor and confirmed by the Council; and

WHEREAS, the Commission shall include nine representatives who actively advocate for or represent the interests and concerns of each of the following minority groups: Latinos, African-Americans, Native Hawaiians or other Pacific Islanders, Native Americans, Asians, Disabled persons, Lesbian/Gay/Bisexual/Transgender (LGBT) persons, Women, and Disabled Veterans; and

WHEREAS, the remaining two members of the Commission shall be appointed from the City at large; and

WHEREAS, members shall serve two-year terms and each member shall serve until a successor is duly appointed and qualified; and

WHEREAS, the Mayor now seeks confirmation of an appointment to the Commission; and

WHEREAS, the Office of the City Attorney has drafted this resolution based on the information provided by City staff, including information provided by affected third parties and verified by City staff, with the understanding that this information is complete, true, and accurate; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the following appointment by the Mayor of the City of San Diego, to serve as a member of the Citizens Equal Opportunity Commission, for a term expiring as indicated, is made and hereby confirmed:




