A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO CONFIRMING A REAPPOINTMENT TO THE ETHICS COMMISSION.

WHEREAS, the Ethics Commission (Commission) is established in the San Diego Municipal Code under Chapter 2, Article 6, Division 4 (Municipal Code) to monitor, administer, and enforce the City of San Diego's (City) governmental ethics laws, and other duties set forth in that Division; and

WHEREAS, the Municipal Code provides that the Commission shall consist of seven members appointed by the Mayor from a pool of nominees submitted by the members of the Council of the City of San Diego (City Council) and City Attorney, subject to confirmation by a majority of the City Council; and

WHEREAS, the Municipal Code provides that the members shall serve staggered four-year terms; each member shall serve until a successor is duly appointed and confirmed; and all terms must have expiration dates of June 30; and

WHEREAS, the Municipal Code provides that the Commission shall reflect the diversity of the City, and include: at least two members who have been a candidate for an elective governmental office, have worked as a treasurer or other high-level position in a campaign for elective governmental office, or have held an elective governmental office; and at least three attorneys in good standing with the State Bar of California; and

WHEREAS, the Municipal Code requires that no more than three members of the Commission shall be registered with the same political party; and
